The Legislative Reference Bureau is requested to submit a report containing its findings to the Legislature not later than twenty days prior to the convening of the Regular Session of 2008.

Your Committee received testimony in opposition to this Resolution from the State Health Planning and Development Agency. The Legislative Reference Bureau offered comments.

Your Committee finds that it would be instructive to ascertain and compare the processes and procedures used by other states and jurisdictions with regard to the determination of need
