Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 1222, S.D. 3, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO INCOME TAXATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Establish that all energy technology systems must be installed and placed in service in the State of Hawaii to obtain the State's income tax energy tax credit; and
- (2) Expand tax credits applicable to shareholder pro rata shares in S corporations.

Your Committee on Conference has amended this measure by changing the applicable years of this measure from taxable years

beginning after December 31, 2007, to taxable years beginning after December 31, 2006.
