"A BILL FOR AN ACT RELATING TO THE MUSEUM OF HAWAIIAN MUSIC AND DANCE,"

The purpose of this bill is to preserve Hawaii's unique cultural heritage by establishing the temporary Museum of Hawaiian Music and Dance Committee to investigate items relating to, and develop plans for, the Museum of Hawaiian Music and Dance.

The State Foundation on Culture and the Arts, Hawaii Government Employees Association, Hawaiian Music Hall of Fame, Ululoa Productions, Mountain Apple Company, and several concerned individuals supported this bill. The Department of Business, Economic Development, and Tourism and the Hawaii Tourism Authority supported the intent of this measure.

Your Committee has amended this measure by:

- (1) Changing its effective date to July 1, 2020, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for style, clarity, and consistency.
