Richardson School of Law. She is a partner in the law firm of Henderson Gallager & Kane and is being nominated for reappointment to the Board of Directors of the Research Corporation of the University of Hawaii. Ms. Kane's prior work experience includes the practice of law in the areas of civil litigation, insurance defense and coverage, personal injury, no-fault insurance law, casualty liability, bad faith, premises liability, and construction defects, as well as service as a law clerk for a Circuit Court judge and as a legislative aide. She is also a member of Sisters Offering Support, the William S. Richardson School of Law Alumni Association, the American Bar Association, the Hawaii State Bar Association, Hawaii Women Lawyers, the Native Hawaiian Bar Association, the Iolani School Alumni Association, Daughters of Hawaii, and Delta Theta Phi.

Testimony in support of the nominee was submitted by the Hawaii Government Employees Association, the State Council of Hawaiian Homestead Associations, the Waimanalo Hawaiian Homes Association, and ten individuals.
