Your Committees find that the National Indian Education Association is the oldest national association devoted to the education of indigenous people in the United States. education of Native Hawaiians is a focus of the Association. 2006, Dr. VerlieAnn Leimomi Kapule Malina-Wright was installed as the first President of the Association of Native Hawaiian ancestry due to her experience, demonstration, and advocacy of teaching and conducting classes entirely in Hawaiian. This year, the Association will hold its annual convention in Honolulu on October 25 to 28, 2007, and your Committees look forward to and welcomes the Association upon its arrival in October. Furthermore, your Committees recognize the important work of the



National Indian Education Association, and appreciate the Association's focus on Native Hawaiian education and recognizing Hawaii's unique distinctions in indigenous education.

As affirmed by the records of votes of the members of your Committees on Water, Land, Agriculture, and Hawaiian Affairs and Transportation and International Affairs and Education that are attached to this report, your Committees concur with the intent and purpose of S.C.R. No. 157 and recommend its adoption.
