The purpose of this measure is to improve patient safety and reduce other possible negative outcomes of medical care.

Your Committee further finds that an examination of legislation of other States targeted at reducing negative medical outcomes could help the efforts of local health care stakeholders to continue improvements in patient safety measures in Hawaii.
