"SENATE RESOLUTION CONVENING AN INTERNATIONAL NETWORK
ADDRESSING DOMESTIC VIOLENCE AND SEX ASSAULT,"

beg leave to report as follows:

The purpose of this measure is to request the Commission on
the Status of Women to convene a network of organizations for the
support and development of local and international organizations
to address domestic violence and sex assault issues.

Your Committees received testimony in support of this measure
from the Sex Abuse Treatment Center, Kapiolani Medical Center;
Hawaii State Commission on the Status of Women; and one
individual.

Domestic violence and sex assault is an international issue
that permeates all levels of society, affecting people regardless
of age, income, education, religion, or culture. Organizations in
countries around the world look to their counterpart organizations
in the United States for leadership and methodologies to treat and
prevent the occurrence of domestic violence and sex assault.

Hawaii is the gateway between the United States and its Asian
neighbors, making Hawaii-based organizations addressing domestic
violence and sex assault natural conduits for international
cooperation on this issue.


