HB 429 RELATING TO THE ISSUANCE OF SPECIAL PURPOSE EDN, FIN REVENUE BONDS TO ASSIST SACRED HEARTS ACADEMY. Authorizes the issuance of up to \$10,000,000 in special purpose revenue bonds to assist Sacred Hearts Academy. HB 504 RELATING TO THE ISSUANCE OF SPECIAL PURPOSE EDN, FIN REVENUE BONDS FOR LE JARDIN ACADEMY. Authorizes the issuance of special purpose revenue bonds for Le Jardin Academy for the construction, improvement, and equipping of its educational facilities. HB 581 RELATING TO THE ISSUANCE OF SPECIAL PURPOSE EDN, FIN REVENUE BONDS FOR HANALANI SCHOOLS. Authorizes the issuance of special purpose revenue bonds for Hanalani Schools. HB 627 RELATING TO THE ISSUANCE OF SPECIAL PURPOSE EDN. FIN REVENUE BONDS FOR HAWAII PREPARATORY ACADEMY. Authorizes the issuance of special purpose revenue bonds for Hawaii Preparatory Academy. HB 63 MAKING AND APPROPRIATION FOR THE UNIVERSITY OF HED/EDN, FIN Appropriates funds to the University of Hawaii for a robotics education coordinator. HB 767 RELATING TO THE RUNNING START PROGRAM FOR HED/EDN, FIN COLLEGE PREPARATION. Appropriates \$50,000 for each year of the fiscal biennium to the GEAR UP Hawaii scholarship fund for the scholarships to students in underrepresented populations in higher education for tuition at the University of Hawaii to participate in the running start college preparatory program and ensures credit for both high school and college degrees is granted for courses taken while in the program. HED/EDN, FIN HB 1014 RELATING TO EDUCATION. Changes the performance standards commission membership and reporting schedule. Clarifies the intended purpose of the Hawaii educator loan program and amends the loan forgiveness incentive provisions. Appropriates funds to the University of Hawaii for the office of school redesign, teacher education and professional development, the master of education in teaching degree program, additional staff for the Hawaii educational policy center, and the Hawaii educator loan program. HB 1530 RELATING TO EDUCATION. HED/EDN, FIN Creates an educational assistant loan program and special fund in the University of Hawaii. Creates another special fund for certain loans to teachers and educational assistants to be forgiven after employment at

rural public schools for a specified number of years as determined by

the department of education.

HB 15	RELATING TO EDUCATION. Establishes the Felix stipend revolving fund, which shall be used by the department of education to deposit moneys received as repayment from students who have broken their contractual Felix stipend agreement with the department of education.	EDN/HED, FIN
HB 1268	RELATING TO INNOVATION IN EDUCATION.	EDN/HED, EDB, FIN
HB 18	RELATING TO EDUCATION.  Authorizes the teacher standards board to suspend its policies, rules, and standards when extenuating circumstances require.	EDN, LAB, JUD
HB 19	RELATING TO EDUCATION.  Creates the facilities alignment commission to revitalize school facilities by developing and submitting recommendations for areas for new school construction, schools for expansion, and schools for consolidation or closure. Allows the legislature to disapprove these recommendations only in their entirety. If no legislative disapproval occurs, requires the board of education to comply with these recommendations.	EDN, FIN
НВ 24	RELATING TO TEACHERS. Provides greater incentives for National Board Certified teachers to work at schools in restructuring under the No Child Left Behind Act, by giving them an additional \$5,000 bonus per year. Appropriates funds.	EDN, LAB, FIN
НВ 26	RELATING TO EDUCATION. Establishes salaries for the members of the board of education. Appropriates funds.	EDN, LAB, FIN
НВ 593	RELATING TO ATHLETIC TRAINERS. Requires licensing for athletic trainers.	EDN, CPC, FIN
НВ 598	RELATING TO EDUCATION.  Creates an online learning task force to develop a systematic plan to expand opportunities for online learning, to enhance the learning experiences of students across the state.	EDN, FIN
