Increases criminal penalties for illegal disposal of solid waste. Establishes an illegal dumping awareness program under the department of health, to administer classes relating to illegal dumping

awareness.

Establishes chapter 125C as the enabling statue for the State's energy emergency preparedness program's coverage of all forms of energy emergencies, irrespective of cause, consistent with the threats to energy security and the state energy emergency preparedness program. Clarifies that the Director of DBEDT is the state energy resource coordinator who is authorized to acquire and use energy industry information obtained by the public utilities commission. Redefines the types of information that all energy companies may be required to submit to the energy resources coordinator in the case of an energy

Require agencies to provide priority handling and processing, and expedite action on all state and county permits required for renewable

energy projects.
