EDB, EEP, FIN

Directs the auditor to conduct a financial and management audit of NELHA's deep seawater pumping system and establish a reasonable rate structure that includes consideration of NELHA's effect on the economy. Freezes rates until the audit is complete. (HB200 HD1)
