HB 1419 RELATING TO ARTICLE VII, SECTION 6, OF THE

CONSTITUTION OF THE STATE OF HAWAII.

Provides for the Constitutionally mandated income tax refund or credit when the state general fund balance at the close of each of two successive fiscal years exceeds 5% of general fund revenues for each

of the two fiscal years.

HB 1434 RELATING TO INCOME TAX CREDIT.

Provides a mandatory tax credit to taxpayers pursuant to article VII,

section 6 of the Constitution of the State of Hawaii.

HB 1491 RELATING TO INCOME TAX CREDIT.

Extends the period to claim the low-income household renter's tax

credit from twelve to thirty-six months.

HB 1487 RELATING TO LOW-INCOME REFUNDABLE TAX CREDIT.

Extends the period to claim the low-income tax credit from twelve to

thirty-six months.

HB 501 RELATING TO LOW-INCOME REFUNDABLE TAX CREDIT.

Increases the low-income refundable tax credit.

HB 1799 RELATING TO TAXATION.

Provides for a state earned income tax credit.
