	Provides a cause of action for private persons who suffer retribution from employers for whistleblower activities related to the state false claims act.	
HB 1447	RELATING TO NOISE.	TRN, JUD, FIN
	Establishes a noise abatement zone for motor vehicles and mopeds and assesses an escalating fine starting at \$100 and impoundment of vehicles for transgressors.
