SB 1931 SD2, HD1 (HSCR1275) RELATING TO EDUCATION.

EDN/HED, LAB/EDB, FIN

Establishes and appropriates funds for an educational workforce working group under DBEDT, to examine and address issues workforce and workforce-related education issues. Requires DOE to include in its strategic plan, plans for workforce-related needs. Requires UH to submit a report to the Legislature on its workforce development efforts. Appropriates funds for positions to assist DOE with its workforce development efforts. (SB1931 HD1)
