НВ 227	RELATING TO HELMET USE BY MINORS. Requires persons under the age of eighteen to wear a helmet while operating an all terrain vehicle on public property. Provides fines for violations.	TRN, JUD, FIN
HB 235	RELATING TO ALL TERRAIN-VEHICLES. Limits right to operate all terrain-vehicles to adults. Requires all terrain-vehicles to have mufflers and not be operated on public lands. Requires retailers to inform buyers of requirements prior to sale or rental.	TRN, EDB, JUD
HB 351	RELATING TO HIGHWAY SAFETY. Establishes the photo red light imaging detector system program. Authorizes counties to administer the program.	TRN, JUD, FIN
HB 352	RELATING TO HIGHWAY SAFETY. Establishes the photo speed imaging detector system program. Authorizes counties to administer the program.	TRN, JUD, FIN
HB 154	RELATING TO MOTOR VEHICLE SAFETY. Redefines highly intoxicated driver. Establishes evidence and sentencing parameters for highly intoxicated drivers. Establishes minimum and maximum administrative license revocation periods for highly intoxicated drivers.	TRN, JUD

RELATING TO TRANSPORTATION.

Allows State to enter into agreements with private entities to build, operate, own, or finance transportation facilities including toll highways. Appropriates \$ and \$ for FY 2007-2008 and FY

HB 64

RELATING TO HARBORS.

TRN, FIN

Authorizes the department of transportation to partner with a private developer to purchase or lease land for an intra-island ferry or water

taxi service at west Oahu.

HB 736

RELATING TO OCEAN RECREATION AND COASTAL AREAS

TRN, WLH, FIN

PROGRAMS.

Transfers small boat harbors, boating, ocean recreation, and coastal areas programs, from DLNR back to DOT. Allows DLNR to retain its

present scope of jurisdiction over enforcement of the programs.

RELATING TO FIXED GUIDEWAY STATION ENTERPRISE

ZONES.

Creates enterprise zones within a half-mile radius of stations of a fixed guideway system on Oahu. Grants various tax concessions relating to enterprise zones to qualified businesses, including new construction of

affordable housing within those zones.
