НВ 227	RELATING TO HELMET USE BY MINORS. Requires persons under the age of eighteen to wear a helmet while operating an all terrain vehicle on public property. Provides fines for violations.	TRN, JUD, FIN
HB 235	RELATING TO ALL TERRAIN-VEHICLES. Limits right to operate all terrain-vehicles to adults. Requires all terrain-vehicles to have mufflers and not be operated on public lands. Requires retailers to inform buyers of requirements prior to sale or rental.	TRN, EDB, JUD
HB 351	RELATING TO HIGHWAY SAFETY. Establishes the photo red light imaging detector system program. Authorizes counties to administer the program.	TRN, JUD, FIN
HB 352	RELATING TO HIGHWAY SAFETY. Establishes the photo speed imaging detector system program. Authorizes counties to administer the program.	TRN, JUD, FIN
HB 154	RELATING TO MOTOR VEHICLE SAFETY.  Redefines highly intoxicated driver. Establishes evidence and sentencing parameters for highly intoxicated drivers. Establishes minimum and maximum administrative license revocation periods for	TRN, JUD

HB 372 RELATING TO THE DEPARTMENT OF TRANSPORTATION'S TRN, HED, FIN ENGINEERING SCHOLARSHIP PROGRAM. Promotes the civil engineering profession and enhances the recruitment and retention of civil engineers in the department of transportation by providing financial assistance, on-the-job training, and educational opportunities to qualified students of Hawaii. HB 70 RELATING TO TRANSPORTATION. TRN, EDB, FIN Allows State to enter into agreements with private entities to build, operate, own, or finance transportation facilities including toll highways. Appropriates \$ and \$ for FY 2007-2008 and FY 2008-2009, respectively. RELATING TO TRANSPORTATION. HB 721 TRN, EDB, FIN Allows private entities to enter into agreements to construct, improve, maintain, and operate transportation facilities in the State. RELATING TO TRANSPORTATION. HB 1424 TRN, EDB, FIN Authorized DOT and county agencies to negotiate public-private partnership agreements under which private partners can assess tolls, fares, or other user fees as compensation for the private finance, planning, design, construction, operation, or maintenance of transportation improvements on public property. RELATING TO NOISE. HB 1447 TRN, JUD, FIN Establishes a noise abatement zone for motor vehicles and mopeds and assesses an escalating fine starting at \$100 and impoundment of vehicles for transgressors. HB 1484 RELATING TO SPEEDING. TRN, JUD, FIN Imposes graduated fines for violation of noncompliance with speed limit law for 1st to 3rd convictions and deposits fines into speed control special fund under the director of transportation to fund projects to control noncompliance with speeding laws. RELATING TO MOTOR VEHICLE ACCIDENT INVESTIGATION. TRN, PSM, FIN HB 1549 Establishes a multidisciplinary accident investigation team in the police department of any county with a population in excess of 500,000 persons for the purpose of investigating major accidents on state roadways in a manner designed to minimize lane and roadway closures during the investigation. Appropriates funds. HB 64 RELATING TO HARBORS. TRN, FIN Authorizes the department of transportation to partner with a private developer to purchase or lease land for an intra-island ferry or water taxi service at west Oahu. RELATING TO OCEAN RECREATION AND COASTAL AREAS HB 736 TRN, WLH, FIN PROGRAMS. Transfers small boat harbors, boating, ocean recreation, and coastal areas programs, from DLNR back to DOT. Allows DLNR to retain its present scope of jurisdiction over enforcement of the programs.

RELATING TO FIXED GUIDEWAY STATION ENTERPRISE ZONES.

TRN, EDB, FIN

Creates enterprise zones within a half-mile radius of stations of a fixed guideway system on Oahu. Grants various tax concessions relating to enterprise zones to qualified businesses, including new construction of affordable housing within those zones.
