HB 1899

RELATING TO KAWAI NUI MARSH.

WLH, FIN

Requires the City and County of Honolulu to transfer to the State a parcel of pristine wetlands known as Kawai Nui Marsh, effective September 1, 2007. Transfers another parcel of Kawai Nui Marsh to

the State.

HB 1104

RELATING TO HISTORIC PRESERVATION.

TAC, WLH

HD1 (HSCR232) Requires consultation with the kahuna nui of the Mookini heiau before

any alterations or improvements to the state monument and before any

additional organized profitmaking venture involving the state monument takes place (HB1104 HD1).

HB 685

RELATING TO PUBLIC LANDS.

WLH, FIN

Authorizes the board of land and natural resources to designate an improvement district when it determines that there is a need for replanning, renewal, or redevelopment of an area's infrastructure.

HB 477

RELATING TO COASTAL ZONE MANAGEMENT.

WLH, FIN

Requires the denying authority to publish public notice of any denial of an application for a Special Management Area (SMA) Emergency Permit, SMA Minor Permit, and SMA Use Permit within twenty days

after denial of the application.

HB 1389

RELATING TO TIME SHARES IN LAND COURT.

WLH, CPC/JUD

Deregisters fee simple time share interest from the Land Court System.
