HD1 (HSCR848) APPEAL COURT.

Clarifies that an appeal by a taxpayer to the Tax Appeal Court from a

board of review decision, or the decision of an equivalent county administrative body, must be served on the Director of Taxation or county administrator of real property tax assessment within 30 days of the date of the final assessment to properly confer jurisdiction over the

appeal. (HB1256 HD1)
