SB 1342

RELATING TO THE PERFECTION OF APPEALS TO THE TAX

EDT/IGM, JDL

APPEAL COURT.

Clarifies that an appeal by a taxpayer to the Tax Appeal Court from a board of review decision, or the decision of an equivalent county administrative body, must be served on the Director of Taxation or county clerk within 30 days of the date of the final assessment to

properly confer jurisdiction over the appeal.

SB 1497

RELATING TO CONFORMITY OF THE HAWAII INCOME TAX LAW TO THE INTERNAL REVENUE CODE.

EDT, WAM

Amends Hawaii's income tax law to conform with changes to the

Internal Revenue Code. (Short Form)

SB 1499

RELATING TO TAX ADMINISTRATION.

EDT, WAM

Conforms Hawaii tax law to federal tax law relating to tax

administration and criminal tax enforcement.

SB 711

RELATING TO TAXATION.

EDT, WAM

Establishes a ten-year statute of limitations on tax collections. Clarifies that the three-year statute of limitations on tax assessments for the general excise tax, use tax, and other period taxes begins

running from the filing of each periodic return.

SB 675

PROPOSING AN AMENDMENT TO ARTICLE VII, SECTION 3,

EDT, JDL

OF THE HAWAII CONSTITUTION, TO CHANGE THE APPOINTMENT OF THE TAX REVIEW COMMISSION TO

EVERY TEN YEARS.

Proposes constitutional amendment to require tax review commission

to meet every ten years instead of five.

Provides an income tax deduction to residential unit owner occupants for qualifying costs of installation of an automatic fire sprinkler system

SB 863 RELATING TO LOW-INCOME REFUNDABLE TAX CREDIT. EDT, WAM Increases the low-income refundable tax credit. RELATING TO HIGH TECHNOLOGY. SB 896 EDT, WAM Appropriates \$150,000 in FY 2007-2008 to the high technology development corporation to negotiate a 10-year lease guaranty to construct the Asia Pacific International Research Center for high technology in Kakaako. SB 707 RELATING TO A NEW MARKETS TAX CREDIT. EDT, WAM Provides a new markets tax credit of a certain percentage of the amount paid to a qualified community development entity for a
