SB 1180 RELATING TO EDUCATION.

EDU, WAM

Amends definition of "weighted student formula"; appropriates funds to DOE to assist schools with the transition to the new spending

method.

SB 1136 RELATING TO EDUCATION.

EDU, WAM

Establishes the weighted student formula augmentation special fund to assist schools in transitioning to the weighted student formula based on certain criteria. Appropriates funds to the special fund. Allows complex area superintendents to reallocate resources within the complex area. Excludes moneys for custodial services, classroom cleaners, and minor repairs and maintenance from the weighted student

formula calculation.

SB 99 RELATING TO THE COMMITTEE ON WEIGHTS IN THE **EDU**

DEPARTMENT OF EDUCATION.

Requires that the department of education committee on weights meet

biennially every odd numbered year, instead of annually.

SB 1648 RELATING TO EDUCATION.

Establishes the applied learning high school academies program for department of education public schools; creates a tax credit for experiential learning opportunities; appropriates an unspecified

amount.
