| S.B. 164 | RELATING TO NURSE AIDES Certifies nurse aides who work in nursing facilities participating in medicare and medicaid programs and in other state licensed and certified health care settings. | НЅР/НТН, СРН |

| S.B. 816 | RELATING TO PRESCRIPTION DRUG COST CONTAINMENT AND AFFORDABLE ACCESS Requires the director of human services to establish a pharmacy best practices and cost control program including Medicaid and other state public assistance health benefits plans, in which any public and private health plan may participate. Includes a prescription drug preferred list and prior authorization review process. Requires drug manufacturers to disclose economic benefits of \$25 or more provided to persons who prescribe, dispense, or purchase prescription drugs. | HTH/HSP, CPH |

| S.B. 979 | RELATING TO SUICIDE PREVENTION Establishes a youth suicide early intervention and prevention program. Makes appropriations. | HSP/HTH, WAM |
| S.B. 1100 | RELATING TO THE HAWAII CHILDREN'S HEALTH CARE PROGRAM Creates a three-year pilot program in which DHS pays half of the premiums for the health care provided by a mutual benefit society to uninsured children thirty-one days to eighteen years old who are ineligible for other state or federal health care coverage. Appropriates funds. Sunsets June 30, 2011. | HSP/HTH, WAM |
| S.B. 1115 | RELATING TO PERINATAL CARE Appropriates funds for the pilot perinatal clinic within the UH medical school department of obstetrics, gynecology, and women's health to help women with a history of substance abuse. | HTH/HSP, WAM |
| S.B.1176 | RELATING TO CHILDREN Amends early intervention services law to be consistent with the reauthorized Individuals with Disabilities Education Act of 2004. | HTH/HSP |
