HB 1248 HD1 (HSCR393)	RELATING TO NAME CHANGES. Prohibits covered offenders subject to registration requirements from petitioning for name changes. (HB1248 HD1)	JDL
HB 1513 HD1 (HSCR395)	RELATING TO ELECTION OFFENSES. Increases the financial penalties levied against those who are found guilty of an election fraud. (HB1513 HD1)	JDL
HB 389 HD1 (HSCR482)	RELATING TO ELECTIONS. Prohibits candidates for public office from appearing in public service announcements from the time of filing nomination papers until the time the person is no longer a candidate. (HB389 HD1)	JDL

Permits agencies to withhold individuals' social security numbers and home addresses before publicly disclosing, upon request, information concerning contract hires and consultants employed by agencies, and certified payroll records on public works contracts.
