SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO REVIEW THE USE OF THE
PREDICTIVE ASSESSMENT OF READING PROGRAM TO TEACH READING
TO STUDENTS.

1 WHEREAS, Hawaii's public school children lag far behind the
2 national average in measures of literacy; and

3
4 WHEREAS, in the 2002 Stanford Achievement Tests (SATs),
5 Hawaii's public school scores remained well below the national
6 average with verbal scores dropping one point, from four hundred
7 sixty-three to four hundred sixty-two, while the national
8 average is over forty points higher at five hundred four; and

9
10 WHEREAS, new paradigms of learning need to be introduced in
11 the classroom and at home, as the current methodologies are not
12 helping our children learn to read at a high level of
13 functioning; and

14
15 WHEREAS, a new conceptual model of language acquisition
16 being used successfully by ASSETS School in Honolulu since 1991
17 is the Predictive Assessment of Reading Program, which is a
18 standardized assessment that can be administered by any teacher
19 with thirty minutes of training, and will yield immediate
20 assessment results that are downloaded from the Predictive
21 Assessment Reading Program website; and

23 WHEREAS, an important aspect of the Predictive Assessment
24 Reading Program is its ability to identify students who are in a
25 risk category and its ability to provide remedial instruction;

28 WHEREAS, ASSETS School indicated that there is a way to
29 predict at what levels children in grades kindergarten, first,
30 second, and third will achieve in literacy skills by the eighth
31 grade, which is particularly important information because

1 current policies require that children fail significantly before
2 special instruction is available to them; now, therefore,
3

4 BE IT RESOLVED by the Senate of the Twenty-fourth
5 Legislature of the State of Hawaii, Regular Session of 2007, the
6 House of Representatives concurring, that the Department of
7 Education, in consultation with the Head of School of ASSETS
8 School, is requested to conduct a review and analysis of the
9 Predictive Assessment Reading Program to determine the
10 feasibility of using it as a potential literacy benefit for
11 public school teachers and students and to submit the results of
12 the analysis to the Legislature at least twenty days prior to
13 the convening of the Regular Session of 2008; and

15 BE IT FURTHER RESOLVED that certified copies of this
16 Concurrent Resolution be transmitted to the Superintendent of
17 Education, the Chairperson of the Board of Education, and to the
18 Head of School of ASSETS School.
