SB 934	RELATING TO AGRICULTURE.  Authorized the agribusiness development corporation to issue revenue bonds to purchase land in central Oahu from the Galbraith trust; appropriates funds to purchase the lands; enables the agribusiness development corporation to contract with lending institutions to provide lease management services. SB 659	RELATING TO AGRICULTURE.  Appropriates \$200,000 to plan a terminal market pilot program on the Big Island; appropriates \$50,000 for the Department of Agriculture (DOA) to hire a consultant to assist in planning terminal markets; authorizes \$3,000,000 in general obligation bonds to finance construction and equipment for a terminal market and vacuum cooling plant on the island of Hawaii; requires the consultant to work with DOA to form a Committee relating to terminal markets. SB 1758	RELATING TO THE AGRIBUSINESS INCUBATOR PROGRAM. Appropriates funds for the agribusiness incubator program to continue until replacement federal funding can be secured.	WAH, EDT, WAM
SB 1220	RELATING TO AGRICULTURAL TAX CREDITS. Establishes the Important Agricultural Land Agricultural Business Tax Credit.	WAH, EDT, WAM
SB 1221	RELATING TO AGRICULTURAL TAXATION. Establishes the agricultural business investment tax credit.	WAH, EDT, WAM
SB 1307	RELATING TO AGRICULTURE. Creates a dairy and egg farm revitalization and food security program. Appropriates \$3.3 million in each year of the fiscal biennium.	WAH, WAM
