STANDING COMMITTEE REPORTS

Representative Sonson, for the Committee on Labor & Public Employment presented a report (Stand. Com. Rep. No. 1219), recommending that H.C.R. No. 48, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Caldwell, seconded by Representative B. Oshiro and carried, the report of the Committee was adopted and H.C.R. No. 48, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT TO CONDUCT A STUDY ON PROVIDING CHILD CARE SERVICES TO CHILDREN OF STATE EMPLOYEES," was referred to the Committee on Finance with Representatives Herkes, Luke, Saiki, Souki and Thielen being excused.

At 12:13 o'clock p.m., Representative Say requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:13 o'clock p.m.

Representative Cabanilla, for the Committee on International Affairs presented two reports:

(Stand. Com. Rep. No. 1220), recommending that H.R. No. 29, as amended in HD 1, be referred to the Committee on Judiciary; and

(Stand. Com. Rep. No. 1221), recommending that H.C.R. No. 50, as amended in HD 1, be referred to the Committee on Judiciary.

Representative Caldwell moved that the reports of the Committee be adopted, and that H.R. No. 29, HD 1, and H.C.R. No. 50, HD 1, be referred to the Committee on Judiciary, seconded by Representative B. Oshiro.

Representative Morita rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Cabanilla rose to speak in support of both measures, stating:

"Mr. Speaker, I rise in strong support of Stand. Com. Rep. No. 1220, as well as Stand. Com. Rep. No. 1221. I believe that hearing resolutions such as this one and passing them sends a strong message to our community and our constituency, that if they don't have

anybody else to listen to them, they have their own local government to go to and have their issues heard.

"I believe the Committee also took some hits for hearing this Resolution from the media, but it just shows a diversity of thought in our government and in our people. It also gave the opportunity for the Committee members to listen and to hear this man's side of the story.

"On a personal level, I found that the man was indeed a hero to some, because a lot of people think that what he did by going to Mexico was a good thing because he brought back a man that is supposed to be in jail for 122 years. He committed heinous crimes and those crimes need to be repaid to our society. The person that he went after was a very famous and rich man that can actually buy his freedom from another country. And although in the process he might have committed what they call in a foreign country a crime, I think the man needs a hearing from his own local government so we as his neighbors can hear his side of the story. Thank you, Mr. Speaker."

Representative Ward rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in strong support. I begin by thanking not only the Chair of International Relations for hearing it, but also for speaking out with vehemence which she just did.

"This Resolution, HR 50 is simply a gesture on the part of this body to send a message to the authorities in Mexico. It's a gesture that would indicate that a man who's captured a rapist, who has terrorized and raped 86 American women, and who knows after his being in Mexico for six months how many Mexican women may have been subject to that. My office has received hundreds of calls, e-mails from Hawaii, the US and overseas on this issue. It's an outpouring of probably 98% favorable, 2% unfavorable.

"This Resolution simply asks not to extradite a man for the misdemeanor that he has been accused of. And Mr. Speaker, I think that is the essence of why this Resolution is important. In the history of the United States, in the history of this Country, I know of no instances of any man or any woman ever being extradited to a foreign country for a misdemeanor. We just don't do that to our citizens of Hawaii and a constituent who's in my district. Extraditing a man for a misdemeanor.

"As indicated by an earlier no-vote, from the Representative of Kauai, Mr. Speaker, some in this body have been intimidated by this Resolution, believing the naysayers that this is a waste of taxpayers' money and a useless gesture. In terms of how resolutions are useless, ask any Hawaiian in this Chamber, any Hawaiian in the great State of Hawaii if the Hawaiian apology resolution, repeat resolution, was a waste of taxpayer's money or a useless gesture. Or as I spoke of last week, ask any Vietnam veteran if the resolution on the Gulf of Tonkin which started the Vietnam War was a useless resolution or gesture. Was it costly? Did it cost us any money? Well no more than the resolution we passed last week on Darfur. Or the *hei haizi* orphans of China.

"So the naysayers have been a bit frightened by those. It's good that we're subject to public opinion, but we're on the side of what is right to do and what is appropriate, I think we can take strength, Mr. Speaker. So I ask all of my colleagues in defense of this man who saved countless American and Mexican women, and I would also ask kindly that the Chair of Judiciary be bold to hear this Resolution so that we can get the Dog free from the impound that is pending him in a Mexican jail. Thank you, Mr. Speaker."

Representative Evans rose to speak in support of both measures with reservations, stating:

"Thank you, Mr. Speaker. I rise with support with some reservations. I really want to thank the Committee that put this together for trying to really address the fact that he was going after a

rapist, and that justice was trying to be served for the people here. But why I have reservations is that I also believe there needs to be respect for other countries, and what their judicial system is and their process is.

"What I would have liked to have seen in this Resolution is a little bit more language about how we respect Mexico, and we respect their people and their judicial system. That what we hope is that they understand that this was a criminal. In fact, justice has been served here in that hopefully they would respect this body's belief that we're grateful that justice was served on our end, and that extradition will not be necessary in this instance. Just maybe a little bit more language recognizing them and their process. I would have liked to have seen that. Thank you."

Representative Pine rose to speak in support of both measures, stating:

"Yes, I just wanted to rise in strong support of this Resolution. Just very briefly, I want to mention that when we were having problems in Ewa Beach with a lot of criminals that took over the beaches in Ewa Beach, I asked Duane 'Dog' Chapman to help me get some of those people. A lot of them had bonds against them. They went into Hau Bush which is a really risky place and they got all those people. So now the beaches are given back to the children and I hope we support Duane 'Dog' Chapman.

"I would agree. We should add the language that we do respect the Mexican government, but this was a person that raped multiple women and I think that we should stand by this man who's protected us here in many ways. Thank you."

Representative Ching rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. I rise in support of the resolution. My office has received numerous e-mails in support of Mr. Chapman. Mr. Chapman has done a number of positive things in terms of crime control in my district.

"On a final note, there are few that come out in courage to do, to risk their lives to protect others. Not many people are willing to do that. I don't know that many people, and I have a deep abiding respect for all who put their lives on the line for safety of others. And I think I've always felt that way for police officers, etc. Few people put themselves out. So I support the resolution."

Representative Berg rose to speak in support of both measures with reservations, stating:

"Thank you, Speaker. I rise with reservations. I think this is meddling into the affairs of the Judicial Branch. I truly understand where my colleagues may be coming from. Perhaps what might be best to do is to do a resolution or a proclamation of some sort, if we believe that Mr. Chapman's work is worthy of recognition, acknowledging his services. Thank you."

Representative Bertram rose to speak in support of both measures, stating:

"I stand in strong support. Resolutions are good. This represents many people in Hawaii. Some folks who are never affected by any laws, or really have no interest in what we're doing with education or anything else, but they want to see the Dog freed. If that says that we're doing something for them or representing their views, well all the power to them.

"We need to represent all the people of Hawaii. So it may not be of everyone's interest in this room or even some of the people in the paper, it does represent the guy who is changing my oil where I was getting my car fixed. It represented the fellow who was the maintenance worker at the condo I live in. They want to know if

we're doing something for the Dog. I mean, it's a common thing, but it represents true feeling out there.

"The third thing is that no judicial system is perfect. There's nothing wrong with saying that we need to see a better representation in your judicial system. A member of my staff was wrongly held by a judicial system in the Philippines. It took him seven years to get out. And he depended on his government to come to his aid, to represent his interests. And if you read it, you really look at the history of this, you really do see that this is a wrong thing on their part. It is a misdemeanor and it was even reduced by that, even as he explained the circumstances.

"And finally, he is a Hawaii resident. He is a resident of our State and so he deserves our support as he deals with what is, if anyone looks at the actual facts of the matter, that he does deserve our support. And he is a good person. I have to admit that. I don't watch TV. I don't know about any of the things there. But he represented himself very well and is a very honorable person. So I stand in support."

Representative Mizuno rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. In support. Insofar as I'm in support of both Stand. Com. Rep. Nos. 1220 and 1221, I also respect and support the process of the hearing that took place. I think it's very important. Someone once noted that this is a marketplace of ideas and I agree. In fact, we had a number of testifiers that actually were against Duane 'Dog' Chapman and I think it was good to hear that too. To look at both sides, get a better understanding, and move forward. For the forgoing reasons, I stand in support for both Standing Committee Reports. Thank you, Mr. Speaker."

Representative Sonson rose to speak in opposition to both measures, stating:

"Thank you very much, Speaker. I'd like to speak in opposition to this Resolution. I respect the fact that the person we're dealing with, Mr. Dog Chapman, a very popular man. And he has a lot of fans out there. I want us to do something to help him. However, a resolution requesting that a President from a foreign country to drop charges, and the charges are not a misdemeanor as was stated by the Representative from Hawaii Kai.

"If you look at the front page of the Resolution, it does state that he was charged with felony kidnapping. I don't believe that having us support him and having that foreign country to drop a felony charge is something that this body should support. There is a process that has to take place if you commit a crime in another country and there's a law that binds the United States to extradite this particular person, that process will be followed.

"If we do care about this person so much because what we believe is that what he has done was good despite the fact that how he did it was not good, well perhaps another resolution would be more appropriate to ask for leniency if he is found to be guilty of this particular charge of kidnapping.

"Let the process take its place. Maybe he will not be convicted in Mexico because if you did not break the law, he will not be convicted or if he has a great attorney, the charge will be overturned. And if he is convicted and that's the worst case scenario, then I believe it will be proper for us if we really care about this person's plight so much, to ask for leniency at that particular point. At this particular juncture, I cannot support this resolution going forward. Thank you.

Representative Waters rose to speak in support of both measures with reservations, stating:

"In support with reservations. My understanding is that the Representative from Hawaii Kai wants the Judiciary Committee to have a Dog Day Afternoon. And the Mexican government wants to

put the 'Dog' on a leash and put him in the dog pound. It is certain that he is in the dog house and the resolution is simply throwing the dog a bone. But perhaps we should let sleeping dogs lie. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, I will never be able to top that in support or in defense of the use of the term 'dog'. But I do want to share one of the things that did come up in the hearing. Because one of the things that came out was there was a mistranslation of the charge which is a misdemeanor called, deprivation of liberty. It's as if I blocked the door here with the intent to commit a crime. That's what deprivation of liberty is. And that's a misdemeanor.

"But the clerk who got it in the US translated that. The only thing we have is kidnapping. So one of the reasons why we're in the problem that we're in is that the press picked up 'kidnapping' and ran with it, and the felony issue has gone awry. So that's why hopefully the Judiciary will straighten that out because that came out very loud and very clear. Not only from him, but the lawyers who were there and the way that the translation. For example, we don't have in English language a word for 'a street with only a sidewalk on one side', without saying all the words? We don't have that.

"And in the sense of this kidnapping, we didn't have the terminology to express it. That's why I said that earlier. We have never extradited, and all we're asking for is, not get into the nitty-gritty of the court, we're saying don't sent him over there. Settle it while he's still here. There's never been an American extradited on the basis of a misdemeanor.

"Mr. Speaker, the second thing that came out in the hearing is probably more on the personality side. People know he's a bit rough and his language is a bit tough, but it came out to where that hard exterior has a very kind heart behind it. And he said to the Committee and in public. It's not being the hero that I am. Anybody who caught a man on the most wanted list in America would be a hero. He never had a TV show until he did what he did with the Mexican rapist example. He was never the guy who was the hero.

"So we're not here giving accolades to a man. We're not worshipping him. We're trying to say that what he did was brave and for what consequences the Mexican government is asking for extradition is not fair. That's the basis of the Resolution. And if I had my wits about me, I would say the Dog deserves another day in court and in this doghouse."

Representative Manahan rose to speak in support of both measures with reservations, stating:

"Mr. Speaker, reservations. I think as a lawmaking body ourselves, I think we would want our laws to be respected. We should, no matter how imperfect their judicial system may be, also have to respect the process. And I would like the words of the Representative from Waipahu entered as my own," and the Chair "so ordered." (By reference only.)

Representative Cabanilla rose to respond, stating:

"I just wanted to mention, Mr. Speaker, still in support, that the Dog did apologize to the Mexican government. Acknowledging my colleague from Waipahu, that perhaps a resolution that would ask for leniency to the Mexican government would be proper."
