The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2007, convened at 12:07 o'clock p.m., with the Speaker presiding.

The invocation was delivered by Mr. Pieper Toyama of Pacific Buddhist Academy, after which the Roll was called showing all members present with the exception of Representatives Herkes, Morita, M. Oshiro, Takai and Thielen, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Fifth Day was deferred.

Representative Takumi: "The reason for the request for the waiver, Mr. Speaker, is that we did have a full hearing on this.
