"Thank you, Mr. Speaker. I rise with a few comments in support of 1585 and 1586. Convening a taskforce to review and make recommendations concerning the structure and operations of the Hawaii Health Systems Corporation. Why would one stand on Second Reading and on a reso? Well, Mr. Speaker, it's because of what came out in this morning's newspaper. The headline: 'Hawaii in the bottom twenty percent of hospitals in the United States.'

"That was a shocker. And why I'm standing to speak is I know this is going on to the Legislative Management Committee, but I was just going to reemphasize that we need this reso now more than ever. I would encourage the Legislative Management Committee to tighten it up even more to make it even more specific and more powerful because being in the bottom twenty is not only a shocker. We should be in the top twenty, world class and second to none. So thank you, Mr. Speaker."

Representative Belatti rose to speak in support of both measures, stating:

"I also rise to stand in strong support for Standing Committee Report Nos. 1585 and 1586. Mr. Speaker, I stand in strong support. The purpose of these Resolutions are to improve the Hawaii Health Systems Corporation as a system by convening a joint taskforce to review and make recommendations concerning its structure and operations. While many of us are wary of joint taskforces, I think this is an important one because of the long term implications of this measure. "As it was discussed in the Committee on Health, this measure may be a better course of action because of the long term implications any reorganization of the Hawaii Health Systems Corporation may have. There are fiscal implications for future legislators and taxpayers who will bear their responsibility to fund the needs of our public hospitals. But more importantly there will be access to quality healthcare implications that we need to study. I hope and trust, as the Representative from Hawaii Kai also I think alluded to, that these Resolutions will receive a fair hearing in the Committee on Legislative Management and that this body as a whole will be able to consider the Resolution for Final Reading. Thank you, Mr. Speaker."
