I am writing to wholeheartedly support the (re)confirmation of Lillian Koller as Director of the Department of Human Services (DHS.)

I am a new employee of Med-QUEST. Up until the end of December of 2006, I was the Chief Operating Officer of Ohana Pacific Management Company, which owns and operates four nursing facilities on Oahu and Kauai, with approximately 400 nursing facility beds and over 500 employees. I was also the Chair of the Hawaii Long Term Care Association (HLTCA) Board of Directors.

I do not mention these things to attempt to impress anyone. I mention them to put into perspective the fact that I felt so strongly about the positive directions in which DHS has been/is moving that I was motivated to leave these positions, which I had long-endeavored to attain, to enter the field of public service... and that was because I was inspired by Director Koller and what she has been able to and continues to seek to achieve. As you can well-imagine, such significant life and career changes are not made without great trepidation and sacrifice. I would not have made them except for Lillian Koller being DHS Director.

Once Director Koller assumed her position at DHS, within HLTCA, we saw immediate progress being made in areas that had not been addressed under the previous leadership. One of these was the implementation of your own Medicaid Reimbursement Equity Act (Act 294). Despite the law having been passed in 1998, it was not until Director Koller assumed the helm of DHS in 2002 that any real work began on its implementation.

It was also not until Director Koller's tenure that earnest (now fruitful) efforts were made to bring the ABD population into QUEST Expanded Access). This rollover was contained in the original QUEST waiver in 1994, but until now, nothing substantive or productive had been done to implement the program. It is now slated to start July 1, 2008. The inclusion of the ABD population into QUEST will open opportunities for our most fragile Medicaid population to receive the services that they need in a location of their choice that meets their needs. QEXA will not occur as effectively and as it should without the continued leadership of Director Koller.

I would never have left my position within Ohana Pacific and the HLTCA to work for someone who did not have the vision and insight that Director Koller has for the Med-QUEST population – the most needy, frail and vulnerable in our society.

Thank you for considering my heartfelt support of Director Koller and my appeal to you to enable her to continue to so-well-serve our DHS constituency.

Dear Senator Chun Oakland.

I have been working more closely with the Director's office for the past year and seen first hand how the Director listens to ideas and suggestions from program managers, Federal experts, other staff and then makes a decision. The Director is indefatigable; I call her the energizer bunny. She is our Director who has been "shushed" on planes, and in restaurants, because she continues to work regardless of where she is. She works through her cell phone at all hours of day and night; one of her staff told me he was planning on turning his phone off when he was getting married. I don't know if you have worked directly with the Director, especially here at DHS, but although she has an official office with a wooden desk, she works in a conference room, with a conference table large enough to contain all of her projects and where people come in and out of all day. She is in constant communications with others; I do not think she could ever be found sitting quietly behind her desk!

She envisions a better life for Hawaii's citizens; she insists that welfare ensures a life of poverty. She can see so many ways to improve how the Department can help improve the lives of our clients and even more so prevent citizens from becoming our clients. I am asking that you vote for this Director to continue directing. There are 47 months left in this term and we cannot afford any down time for a new group to be put in place and brought up to speed. And speed is what we need here, our Director's speed, as we are facing new and stricter Federal requirements, for example, new rules for TANF recipients, a second all-States Federal review on our Child Protective Services (CFSR2 in 2008/09), State ID cards. Apart from new Federal requirements, that we must comply with, we are in the middle of implementing new State-wide plans to improve how DHS provides services to our clients for example, Motivational Interviewing skills training to all 400+ BESSD and SSD workers, developing a new Child Protective Services System that can be accessed from the field, studying our existing programs to architect a new DHS-wide system, and countless other new activities that are aimed at continuously improving our State services through DHS.

The Director is tireless; she asks more from herself than most of us could ever imagine. She works 7 days a week, all hours of day and night. She inherited a department that was functioning at a base level dictated by the Federal program rules and some State programs and services that had been implemented over time. She has had four years to learn the business and make changes. She has no down time; she pushes herself constantly. I cannot imagine having such strength and energy to continue day in and day out and even in the face of adversity such as negative criticism she doesn't stop. I believe we are so fortunate to have a director at this time who is self-less and who has vision and the strength and energy to drive the department toward that vision.

I ask that you give the Director, what the Governor has requested, and that is another four years to continue moving the department into a better future. I can only hope that at the end of these four years, the department will be headed in a new and sustainable direction, and not fall back into the past complaisancy. The Federal government and many states are moving toward performance-based measurements; how many of us could be expected to be rated "exceeding" in all areas as I am suggesting Director Koller can be rated. - Supporting Hawaiian foster homes for Hawaiian foster children

- Supporting those receiving Temporary Assistance for Needy Families to become self-sufficient and proving medical benefits and child care support to help then continue their independence
- Supporting those with parenting problems and providing assistance without necessarily removing their children.

I spent many years working with victims of domestic violence and there use to be a major concern that when it was felt mandatory to call Child Welfare Services. (CWS) as when a case was accepted, the child or children were taken from the parent (usually the mother.) This left the victim in more of a crisis. In many cases it was clear that the victim of domestic violence needed help in how to raise their children and yet their parenting had not reached abusing their children. These victims were so involved in trying to keep themselves safe they were unable to be appropriate parents to their children. Many needed assistance. The only way they could obtain assistance was if CWS removed their children. I have been very grateful to see that Ms. Koller has helped the Department embrace another way of looking at the issue and helping parents, who need assistance, prior to the crisis of abuse, obtain the services needed without necessarily removing the children.

I have also been grateful to see is that Ms. Koller has worked with all the Human Services programs, including Med Quest to do her up most to maximize federal funding and therefore, more people who are most in need are receiving services that provide more benefits, than in the past.

Working in the State system I have observed the difficultly of change. My prior experience, working in the private and non-profit sectors of the community showed me that everyone is very aware that change is inevitable. That has not been my experience in the public sector.

Change is always difficult. Ms. Koller has shown the moxie to have been able to make these major changes happen. Her leadership is critical for the State of Hawaii to move ahead to continue to provide better and expanded services to those in the most need.

I encourage the committee to confirm Lillian B. Koller as the Director of the Department of Human Services.

Dear Senator Chun Oakland and Committee Members:

I am writing in strong support of the reconfirmation of Lillian B. Koller as Director of the Department of Human Services (DHS).

I am President & CEO of Child and Family Service (CFS) and have been in this position for almost a year now. I have a 32 year career in human services and have worked with various Directors (or Commissioners as we call them back east) of state departments that have the child protection and child welfare mandate like Hawaii's State Department of Human Services (DHS). I have often felt that being a Director of the state department that has responsibility to protect children is the hardest, yet most important, job on earth. It has amazed me at times that anyone would consider taking this job. In my experience, the head of DHS or any similar state department in other states has a no-win job. When a child dies under the Director's watch, the reaction is that the state department has not removed children quickly enough from abusive parents. If DHS then reacts and is quicker to remove children, then those who believe that families should be preserved and foster parents are not the answer, cry for family preservation and say the state is removing children too quickly. I believe this pendulum between child protection and family preservation has always been there and will continue to be there. It will swing sometimes to one extreme or the other and hopefully reach a more reasoned middle ground.

While I have only been in Hawaii less than a year, I met with all of the Directors of state departments that we work with at CFS since we provide multiple services under contract with these state departments. I was most impressed with Director Koller of any of the Directors I met. She was excited about the work DHS and providers and others were doing to improve child welfare services and she wanted to continue to find ways to innovate and provide better services. Her enthusiasm was striking, but she also had ideas that made sense. Her openness to working with other organizations in recognizing that DHS alone could not be effective without engaging the community and the various organizations, both public and private, both grassroots and more traditional, is something I have not often seen in Directors. She has opened up training so it is available to nonprofit providers' staff in addition to her own DHS staff.

I understand that under Director Koller's leadership DHS met the Program Improvement Plan (PIP) goal to reduce harm to children. Child Welfare Services (CWS) cases decreased by 13% at the end of SFY 06. In SFY 06 there were 5,686 active CWS cases compared to 6,538 cases at the end of SFY 05. In addition to the reduction in CWS cases, since December 2005 when DHS initiated its differential response system that allows families to request voluntary services before there is abuse or neglect, there has been a 30% reduction in children removed from their homes. This differential response system was called "Diversion Services" and now is called "Family Strengthening Services." Child and Family Service is a big believer in Family Strengthening Services, and we provide these services on several islands in addition to Oahu.

Two other accomplishments under Director Koller have been: 1) her efforts to identify resource families (foster families) for Native Hawaiian and Part Hawaiian children who make up over 50% of the children in Hawaii who are in foster care; and 2) her development of partnerships with other organizations including the University of Hawaii schools of medicine, social work, law, and nursing as well as the State Department of Health.

In my short time here, I have heard that Director Koller has been viewed by some as "controversial" or for whatever reasons they have not responded well to her. While there may be style issues on her part (and I have not experienced any of this), Director Koller should be reconfirmed in my view since she has accomplished a great deal. When you try to make things

happen and be a "change agent" in any organization, you will get push back and not everyone will support the changes you are making. You can even make a few enemies along the way. However, I know that key staff who work directly with Director Koller have expressed how much they want her to be reconfirmed and how much support they have received from her. They very much want to see her continue as Director so they can work with her to continue to reform the child welfare system in positive ways that will benefit Hawaii's children, families and communities. That to me is what we should all want here in Hawaii. I believe Director Koller has the passion, enthusiasm, commitment, determination and ability to get things done that will continue to make a difference in the lives of Hawaii's people. That is why I so strongly support her reconfirmation.

I hereby submit my testimony in support of reconfirmation of Director Koller.

Given the larger policy picture—that Hawaii is entering into a significant period of inflation and probable, steady decrease of federal funds for human services—policy continuity is needed to assure that Medicaid, related outreach to those coming off welfare, CHIP, and Quest programs succeed in capturing, as much federal match as possible, and consistent state policies to assure that those in most need have timely access to health care and other human services.

In comparison to previous Administrations, Director Koller has succeeded in her ability to maximize Medicaid/Quest services while not requiring repeated requests for emergency appropriations from the legislature

Also, passive reenrollment into the Quest program has assured that those enrolled are not presumed ineligible at the end of the year, thereby requiring the costly re-processing of eligibility (approx. 400 clients), delays in paying providers, and disruption of service.

In further comparison, the Cayetano Administration delayed starting the Children's Health Insurance Program (sadly, the last state in the nation) by not capturing the potential of private donations to serve as state match and then "waiting" on the arrival of tobacco settlement funds. Federal outreach funds to find those coming off welfare but still eligible for Medicaid also languished during the previous administration. Director Koller, on the other hand, has shown strong leadership over the past four years by having instituted policies to better use these federal funds (and also securing more than \$27 million in new federal funds).

Hence, given her strong policy stance in vital programs linked to a large portion of the state's budget, *reconfirmation is prudent*; at least a year or 18 months would be needed for a new director to learn the technicalities of the various state/federal programs and gain the confidence of those at the HHS at Region IX and in Washington, D.C.

Aloha. My name is Lea Grupen. I am a Supervisor at Ho`opono, the agency who works with blind and visually impaired consumers of all ages in the Vocational Rehabilitation and Services for the Blind Division of the Department of Human Services (DHS). It is a pleasure for me to offer these comments in strong support of the confirmation of Lillian B. Koller as Director of DHS for a second term.

Several years ago, our agency began looking at the way we work, and how we could better work together with our consumers to achieve the "American Dream". The Vocational Rehabilitation program, which exists in all 50 states and the territories, is premised on the belief that all citizens should have the opportunity to make decisions for themselves, to participate in higher education, to work in meaningful, high-quality careers, to pay taxes, to contribute to society, and to provide for themselves and their families. Individuals who are blind from birth, or who become blind later in life, need specialized training, tools, and assistance to achieve these goals. While we were doing a good job with this, we felt we could aim higher, stretch further and do even better.

We took a look at successful programs for the blind around the country and found some existing models for training and empowerment. Under Ms. Koller's leadership, we were encouraged to study these role models and to think creatively about how we could emulate them, while still maintaining a sense of Hawaiian identity and individualizing services to each consumer. We were given time and resources for intensive staff training necessary to plan for and implement this new model, which we call our "New Visions" program. Since the implementation of New Visions, I have seen our consumers emerging from

training more empowered and confident, comfortable with their identities as blind and visually impaired people, moving on to higher-level education and employment, and living independently as contributing members of society. As a testimony to our beliefs, we have hired on staff some of the very qualified consumers we have served in the past.

If you look around the room today, you will no doubt see a number of people here with canes. Many are staff and consumers of Ho`opono. They want to tell you of the ways in which our program has changed their lives for the better. I can tell you from my perspective that under the leadership of Lillian Koller, our agency has risen to a new level. As Director, Ms. Koller has created a reputation of being a change agent. It is true that she has encouraged and supported change in our Division; this has taken place largely as a response to the consumers with disabilities whom we serve. From the time she came on board as Director, Ms. Koller consistently communicated a very clear message to staff: she cares deeply about the work we do, providing services and assistance to empower the most vulnerable in our society, so that they may fully participate in life. She has encouraged us to be creative in solving problems, to not be afraid to look at ourselves and ask, "how can we do this better?". She has empowered staff as well as consumers to make suggestions, to work for justice, and to look to a brighter future.

I strongly urge the members of this committee to vote in favor of her nomination.

I have been a social worker with the Department of Human Services, Child Welfare Services (CWS) Branch, for 22 years. I am writing to convey my support that Lillian B. Koller, Director, be reconfirmed.

Director Koller's leadership and courage made it possible for us to implement aggressive system reform in CWS, all for the betterment of the families we serve and for the CWS staff. In July 2003, the Federal Department of Health and Human Services completed a comprehensive review of Hawaii's child welfare systems as part of the Federal Child Family Services Review (CFSR) authorized by Congress in 1997. As a result of Hawaii's CFSR, Director Koller led CWS through aggressive system reform to improve safety, permanency and well-being outcomes for our children and families.

Director Koller's commitment and unrelenting pursuit of improvements made CWS a better agency for our children and families. Director Koller's standards for best practice; improving communication and working relationships with our community partners, sister divisions and government agencies; and removing bureaucratic silos and barriers; all aimed at improving the help that our families are entitled to receive.

Director Koller pushed for the adoption of our Department's new Hawaii Administrative Rule, Confidentiality, which was in the making for many years and was finally adopted in December 2004. Dear Department of Human Service and Public Housing Committee,

My name is Jennifer Grant. I am a biological child of a foster parent. When I heard about Statewide Resource Families (SRF) Program and what it entails I was exhilarated. Just to hear that this program exists is quite gratifying. It is wonderful that Lillian B. Koller embraced this program. It is Mrs. Koller's ambition to open her arms to programs that help to care for Hawaii's keiki.

You might wonder how this program might be important to a biological child of a foster parent. For five years, my mother and I cared for foster children. Some of the children needed psychological counseling. However, there was never one person we could contact to inform the state of their needs. Seeing how Statewide Resource Families (SRF) Program is setup, it cuts the red tap that congests communication. Communication that is vital for the well-being of foster children.

On a personal note, Statewide Resource Families (SRF) Program assesses the welfare of the biological child, as well as the foster child. This again is essential for a positive outcome of a foster family placement. SRF assessment team has created questions that can help with the needs of the biological child as well. As a former biological child, I feel this is crucial. In my past, I have had occasion that I had trouble with a foster child that was close to my age. I felt uncomfortable in confronting my mother. I wished there was a second individual that I could have talked you.

One finial note on the influential and critical need for Statewide Resource Families (SRF) Program, this program enables foster children to have a positive future with a voice. A voice that should be heard not ignored. During those years as a biological foster child, we cared for three little girls, for five years. The state could not find the biological parents and never informed them of visitation dates. In the last year, the biological parents took the state to court for custody back. As the biological child of the foster parent, I knew how the girls were afraid of their mother. During the one visit that did occur, the girls ran out of the room, down the street and banged on the window to the car. The mother's reaction was to call them brats. The court awarded the children back to the biological parents. Within a month, the middle child was thrown out of a 6-story window. This action devastated my mother and I. The child had no voice, the foster parent had no voice, and I had no voice. Statewide Resource Families (SRF) Program gives the foster parent, the foster child and the biological child a microphone to voice out concerns. To voice out concerns that might look minuscule but in long run have huge consequences.

I am more ecstatic that this program exists. The creation of S.T.A.R., Surviving Transition and Reconciliation will be great addition to the SRF program. The program helps to endorse appreciation and a bond between the foster child and biological child. This is a key component that is the foundation of a positive foster family placement. I am happy to have volunteered for the creation of this program. Joy Lacanienta has a great vision of the full picture that is needed, to create a supportive community for everyone that is a member of the foster care system. Lillian B. Koller has the ambition and determination to have the best program available for Hawaii's keiki. The partnership of Joy Lacanienta and Lillian B. Koller will benefit the foster parents, foster child, biological foster child the assessment workers and licensing workers. This vision will make a difference, a life difference for many involved. More than we will ever know It is empowering to see so many individuals support this program. To hear the voice of change from all directions and to be part of the movement toward a better future is life alternating.
