Dear Senator Hanabusa:

Pursuant to Act 242, relating to Uniform Information Practices, during the 2007 year ending December 31, 2007, the Department did not suspend any Police Officer for 1) malicious use of physical force, 3) use and/or possession of drugs and/or narcotics or 4) cowardice; however a Police Officer was suspended and discharged for 2) mistreatment of a prisoner / arrested person.

Attached is a summary of all incidents and violations of Department Policies and procedures which resulted in the suspension or discharge of Police Officers during the period from January 1, 2007 to December 31, 2007 with the following comments:

- While not specified, discipline imposed may be progressive whereby the prior disciplinary histories of an employees are considered.
- The discipline imposed may have been be subsequently amended as a result of the grievance process.
