
A BILL FOR AN ACT

RELATING TO DAMS AND RESERVOIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 179D, Hawaii Revised Statutes, is
2 amended by adding two new sections to be appropriately
3 designated and to read as follows:

4 "§179D- Duty to control water level. The owner of a dam
5 or reservoir shall not allow the actual water level of the
6 reservoir to exceed the design water level.

7 §179D- Duty to maintain dam and reservoir. (a) The
8 owner of a dam or reservoir shall have the duty to manage and
9 maintain the dam or reservoir in safe condition; provided that
10 this duty shall include, but not be limited to, keeping all
11 valves and spillways in working condition and preventing natural
12 and planted foliage, including but not limited to the foliage
13 roots, from compromising the safety of the dam or reservoir.

14 (b) The owner shall have the duty to properly manage and
15 maintain each of the reservoir's water inlet and water outlet
16 points; provided that this management and maintenance shall
17 include but not be limited to annual cleanings."



1 SECTION 2. Section 179D-3, Hawaii Revised Statutes, is
2 amended by adding a new definition to be appropriately inserted
3 and to read as follows:

4 "Design water level" means the maximum water elevation,
5 including the flood surcharge, that a dam is designed to
6 withstand."

7 SECTION 3. Section 179D-8, Hawaii Revised Statutes, is
8 amended to read as follows:

9 **"~~[+]§179D-8[+]~~ Violations; penalties.** ~~[Any person~~
10 ~~violating]~~ It shall be a criminal offense to violate any
11 provision of this chapter or any permit condition or limitation
12 established pursuant to this chapter or to negligently or
13 wilfully ~~[failing]~~ fail or ~~[refusing]~~ refuse to comply with any
14 final order of the board issued as provided herein~~[, shall be~~
15 liable for a civil penalty not to exceed \$500 for each day
16 during which said violation continues]. A violation shall be
17 considered a separate violation for each day during which the
18 violation continues. A person convicted of a criminal offense
19 under this section shall be sentenced as follows:

20 (1) For the first violation, the person shall be fined
21 \$2,000;



1 (2) For the second violation, the person shall be fined
2 \$4,000;

3 (3) For the third and each subsequent violation, the
4 person shall be fined \$8,000 and imprisoned for a term
5 not to exceed five years."


6 SECTION 4. This Act does not affect rights and duties that
7 matured, penalties that were incurred, and proceedings that were
8 begun, before its effective date.

9 SECTION 5. Statutory material to be repealed is bracketed
10 and stricken. New statutory material is underscored.

11 SECTION 6. This Act shall take effect upon its approval.
