TITLE:

A BILL FOR AN ACT RELATING TO UNCLAIMED

PROPERTY.

PURPOSE:

To repeal the permanent escheatment of

unclaimed property to the State.

MEANS:

Repeal section 523A-3.5, Hawaii Revised

Statutes.

JUSTIFICATION:

Section 523A-3.5 states that unclaimed property held by the State for periods ranging from two years to six years, depending upon the value of the property held, be permanently escheated to the State. This provision appears to be in conflict with the intent of the State's Unclaimed Property Program, that is, the State serves as custodian of the unclaimed property and reunites such unclaimed property with its rightful owners. While section 523A-3.5 was enacted in 1996, it has never been implemented. The public has not been harmed by the Department of Budget and Finance's ("Department") not implementing the permanent escheat provisions of section 523A-3.5.

Impact on the public: The public will be positively affected as there will no longer be a time limit for the filing of claims.

Impact on the department and other agencies: This bill will allow the Department to serve as custodian of unclaimed funds in perpetuity. Other departments are not affected.
