
A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR NATURAL DISASTERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the Governor for
2 immediate passage in accordance with section 9 of article VII of
3 the Hawaii State Constitution.

4 SECTION 2. The purpose of this Act is to make emergency
5 appropriations for emergency relief operations in the counties
6 of Hawaii, Maui, Kauai, and the city of Honolulu as a result of
7 the October 15, 2006, Kiholo Bay Earthquake disaster.

8 The legislature finds and declares the appropriations under
9 this Act are in the public interest and ensures the public
10 health, safety, and general welfare of the state.

11 SECTION 3. There is appropriated out of the general
12 revenues of the State of Hawaii the sum of \$ or so much
13 thereof as may be necessary for fiscal year 2006-2007 to cover
14 operational expenses associated with earthquake disaster
15 recovery efforts, including but not limited to national guard
16 personnel on state active duty and helicopter operating
17 expenses.



1 The sum appropriated shall be expended by the department of
2 defense for the purposes of this Act.

3 SECTION 4. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$ or so much
5 thereof as may be necessary for fiscal year 2006-2007 to cover
6 the twenty-five percent non-federal cost share for earthquake
7 disaster recovery projects made eligible under the Federal
8 Emergency Management Agency's public assistance program.

9 The sum appropriated shall be expended by the department of
10 defense for the purposes of this Act.

11 SECTION 5. Each department or agency expending funds
12 authorized by this Act shall submit reports to the legislature
13 no later than January 15, 2008. The information contained in
14 the reports shall:

- 15 (1) Be organized by county;
- 16 (2) Provide summaries of expenditure data on a statewide
17 basis; and
- 18 (3) Include:
 - 19 (A) The date of each expenditure;
 - 20 (B) The purpose and description of each expenditure;
 - 21 (C) The identification of any recipient of payments
22 from each expenditure; and



- 1 (D) For funds not authorized by this Act but
2 nevertheless used by any department or agency for
3 the purposes of this Act:
- 4 (i) The source of those funds, by specific
5 program;
 - 6 (ii) The impact to the programs originally funded
7 by those funds; and
 - 8 (iii) The need for any emergency appropriations
9 that resulted from the diversion of those
10 funds.

11 SECTION 6. Notwithstanding any provision of this Act to
12 the contrary, the appropriations under this Act shall not lapse
13 at the end of the fiscal year for which the appropriations were
14 made. All unexpended and unencumbered balances of the
15 appropriations made in this Act as of the close of business on
16 June 30, 2008, shall lapse.

17 SECTION 7. This Act shall take effect on July 1, 2015.



Report Title:

Emergency appropriation; natural disasters.

Description:

Makes emergency appropriations to DOD for FY 2006-2007 to:

- (1) Cover operational expenses associated with the October 15, 2006, Kiholo Bay earthquake disaster recover efforts in the counties of Hawaii, Maui, Kauai, and the City and County of Honolulu; and
- (2) Cover the 25% non-federal cost share for earthquake disaster recovery projects made eligible under the FEMA Public Assistance program. (HB1345 HD1)
