# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums, or so much  
5 thereof as may be necessary, to fund for fiscal biennium 2007-  
6 2009 all collective bargaining salary increases and other cost  
7 adjustments contained in the agreement negotiated with the  
8 exclusive bargaining representative of collective bargaining  
9 unit (11):

13 SECTION 2. Funds appropriated or authorized by this part  
14 shall be allotted by the director of finance to the appropriate  
15 state departments for expenditure in each respective fiscal year  
16 for the purposes of this part.

1 SECTION 3. There are appropriated or authorized from the  
 2 sources of funding indicated below to program planning,  
 3 analysis, and budgeting (BUF 101) the following sums, or so much  
 4 thereof as may be necessary, to fund for fiscal biennium 2007-  
 5 2009 the salary increases and other cost adjustments authorized  
 6 by chapter 89C, Hawaii Revised Statutes, for state officers and  
 7 employees in the executive branch who are excluded from  
 8 collective bargaining:

12 SECTION 4. Funds appropriated or authorized by this part  
 13 shall be allotted by the director of finance to the appropriate

 18 sources of funding indicated below to program planning,  
 19 analysis, and budgeting (BUF 101) the following sums, or so much  
 20 thereof as may be necessary, to fund for fiscal biennium 2007-  
 21 2009 the Hawaii employer-union health benefits trust fund costs





1 SECTION 8. Funds appropriated or authorized by this part  
 2 shall be allotted by the director of finance to the appropriate  
 3 state departments for expenditure in each respective fiscal year  
 4 for the purposes of this part.

6 SECTION 9. Salary increases and cost adjustments provided  
 7 in this Act for any officer or employee whose compensation is  
 8 paid, in whole or in part, from federal, special, or other funds  
 9 shall be paid wholly or proportionately, as the case may be,  
 10 from the respective funds.

11 SECTION 10. Funds appropriated or authorized by this Act  
 12 that are not expended or encumbered by June 30, 2008, and  
 13 June 30, 2009, of the respective fiscal years, shall lapse as of  
 14 those dates.

15 SECTION 11. This Act shall take effect on July 1, 2007.
