## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR SALARY INCREASES FOR PUBLIC EMPLOYEES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to program planning,  
4 analysis, and budgeting (BUF 101) the following sums, or so much  
5 thereof as may be necessary, to fund for fiscal biennium 2007-  
6 2009 all collective bargaining cost items contained in the  
7 agreements negotiated with the exclusive bargaining  
8 representatives of collective bargaining units (2), (3), (4),  
9 (6), (8), (9), and (13):

15 SECTION 2. Funds appropriated or authorized by this part

There are appropriated or authorized from the sources of funding indicated below to program planning, analysis, and budgeting (BUF 101) the following sums, or so much thereof as may be necessary, to fund for fiscal biennium 2007-2009 the salary increases and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for state officers and employees in the executive branch who are excluded from collective bargaining and belong to the same compensation plans as those officers and employees within bargaining units (2), (3), (4), (6), (8), (9), and (13):

 20 Statutes, for state officers and employees of the judiciary who  
 21 are excluded from collective bargaining and belong to the same

4 SECTION 11. There are appropriated or authorized from the  
5 source of funding indicated below to hospital care-Hawaii health  
6 systems corporation (HTH 210) the following sums, or so much  
7 thereof as may be necessary, to fund for fiscal biennium 2007-  
8 2009 the salary increases and other cost adjustments authorized  
9 by chapter 89C, Hawaii Revised Statutes, for state officers and  
10 employees assigned to the Hawaii health systems corporation who  
11 are excluded from collective bargaining:

14 SECTION 12. Funds appropriated or authorized by this part  
15 shall be allotted by the director of finance to the Hawaii  
16 health systems corporation for expenditure in each respective

19 SECTION 13. Salary increases and cost adjustments provided  
20 in this Act for any officer or employee whose compensation is  
21 paid, in whole or in part, from federal, special, or other funds



1 shall be paid wholly or proportionately, as the case may be,  
2 from the respective funds.

3 SECTION 14. Funds appropriated or authorized by this Act  
4 that are not expended or encumbered by June 30, 2008, and  
5 June 30, 2009, of the respective fiscal years, shall lapse as of  
6 those dates.

7 SECTION 15. This Act shall take effect on July 1, 2007.
