
A BILL FOR AN ACT

RELATING TO CHARTER SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 302B-1, Hawaii Revised Statutes, is
2 amended by amending the definition of "conversion charter
3 school" to read as follows:

4 "**§302B-1 Definitions.** Whenever used in this chapter,
5 unless the context otherwise requires:

6 "Board" means the board of education.

7 "Charter school" refers to those public schools holding
8 charters to operate as charter schools under this chapter,
9 including start-up and conversion charter schools, and that have
10 the flexibility and independent authority to implement
11 alternative frameworks with regard to curriculum, facilities
12 management, instructional approach, virtual education, length of
13 the school day, week, or year, and personnel management.

14 "Charter school review panel" or "panel" means the panel
15 established pursuant to section 302B-3 with the powers and
16 duties to advise and make recommendations to the board regarding
17 issuance and revocation of charters, detailed implementation
18 plan revisions, and charter school evaluations.



1 "Conversion charter school" means:

2 (1) Any existing department school that converts to a
3 charter school and is managed and operated in
4 accordance with section 302B-6;

5 (2) Any existing department school that converts to a
6 charter school and is managed and operated by a
7 nonprofit organization in accordance with section
8 302B-6; [~~or~~]

9 (3) A newly created school, consisting of programs or
10 sections of existing public school populations that
11 are funded and governed independently and may include
12 part of a separate Hawaiian language immersion program
13 using existing public school facilities;

14 (4) A charter school established within an existing
15 department school and operating concurrently with the
16 existing department school, if it is managed and
17 operated by a nonprofit organization in accordance
18 with section 302B-6 or consists of programs or
19 sections of existing public school populations that
20 are funded and governed independently, and may include
21 part of a separate Hawaiian language immersion program
22 using existing public school facilities.



1 "Department" means the department of education.

2 "Detailed implementation plan" means the document that
3 details the charter school's purpose, focus, operations,
4 organization, finances, and accountability, and becomes the
5 basis for a performance contract between the board and the
6 charter school.

7 "Executive director" means the executive director of the
8 charter school administrative office.

9 "Local school board" means the autonomous governing body of
10 a charter school that receives the charter and is responsible
11 for the financial and academic viability of the charter school,
12 implementation of the charter, and the independent authority to
13 determine the organization and management of the school, the
14 curriculum, virtual education, and compliance with applicable
15 federal and state laws, and that has the power to negotiate
16 supplemental collective bargaining agreements with exclusive
17 representatives of their employees.

18 "Nonprofit organization" means a private, nonprofit, tax-
19 exempt entity that:

- 20 (1) Is recognized as a tax-exempt organization under
21 section 501(c)(3) of the Internal Revenue Code of
22 1986, as amended; and



- 1 (2) Is domiciled in this State.
- 2 "Office" means the charter school administrative office.
- 3 "Organizational viability" means that a charter school:
- 4 (1) Has been duly constituted in accordance with its
- 5 charter;
- 6 (2) Has a local school board established in accordance
- 7 with law and the charter school's charter;
- 8 (3) Employs sufficient faculty and staff to provide the
- 9 necessary educational program and support services to
- 10 operate the facility in accordance with its charter;
- 11 (4) Maintains accurate and comprehensive records regarding
- 12 students and employees as determined by the office;
- 13 (5) Meets appropriate standards of student achievement;
- 14 (6) Cooperates with board, panel, and office requirements
- 15 in conducting its functions;
- 16 (7) Complies with applicable federal, state, and county
- 17 laws and requirements;
- 18 (8) In accordance with office guidelines and procedures,
- 19 is financially sound and fiscally responsible in its
- 20 use of public funds, maintains accurate and
- 21 comprehensive financial records, operates in



- 1 accordance with generally accepted accounting
2 practices, and maintains a sound financial plan;
3 (9) Operates within the scope of its charter and fulfills
4 obligations and commitments of its charter;
5 (10) Complies with all health and safety laws and
6 requirements; and
7 (11) Complies with all board directives, policies, and
8 procedures.

9 "Start-up charter school" means a new school established
10 under section 302B-5."

11 SECTION 2. Section 302B-4, Hawaii Revised Statutes, is
12 amended to read as follows:

13 "**§302B-4 Limits on charter schools.** Beginning July 2007,
14 the board, with the recommendation of the panel, may authorize
15 one new start-up charter school for each existing start-up
16 charter school that has received a three-year or longer
17 accreditation from the Western Association of Schools and
18 Colleges or a comparable accreditation authority as determined
19 by the panel, or for each start-up charter school whose charter
20 is revoked. The total number of conversion charter schools
21 authorized by the board, with the recommendation of the panel,
22 shall not exceed twenty-five, provided that conversion charter



1 schools established within an existing department school and
 2 operating concurrently with the existing department school as
 3 authorized by the board, with the recommendation of the panel,
 4 shall not be counted towards the total number of conversion
 5 charter schools allowed under this section, but in no case shall
 6 exceed three."

7 SECTION 3. Statutory material to be repealed is bracketed
 8 and stricken. New statutory material is underscored.

9 SECTION 4. This Act shall take effect on July 1, 2008.
