
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
TWELFTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2007-2008:

5 1. To be expended by the department of land and
6 natural resources:

7 Exploratory testing well, Maui
8 Plans, design, and construction for an
9 exploratory testing well in one of four to
10 be determined upcountry Maui locations:
11 Kula, Pukalani, Makawao, or Ulupalakua.
