A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 356D, Hawaii Revised Statutes, is
2	amended by adding a new section to part I to be appropriately
3	designated and to read as follows:
4	"§356DPublic housing project repairs; partnerships
5	with nonprofit organizations. The authority may contract with
6	nonprofit organizations for the purposes of repairing and
7	renovating public housing projects, without regard to chapter
8	103D. The authority may adopt rules in accordance with chapter
9	91 for purposes of this section."
10	SECTION 2. Section 356D-9, Hawaii Revised Statutes, is
11	amended by amending subsection (a) to read as follows:
12	"(a) The authority may:
13	(1) Obtain the aid and cooperation of other government
14	agencies in the planning, construction, and operation
15	of public housing projects and enter into agreements
16	and arrangements as it deems advisable to obtain aid
17	and cooperation;

1	(2)	Arrange or enter into agreements with any government
2		agency for the acquisition by that agency of property,
3		options, or property rights; for the furnishing,
4		installing, opening, or closing of streets, roads,
5		alleys, sidewalks, or other places; for the furnishing
6		of property, services, parks, sewage, water, and other
7		facilities in connection with public housing projects;
8		for the repair and renovation of public housing
9		projects by qualified, able-bodied persons in the
10		custody of the department of public safety; or for the
11		changing of the map of a political subdivision or the
12		planning, replanning, zoning, or rezoning of any part
13		of a political subdivision;
14	(3)	Procure insurance or guarantees from any government
15		agency for the payment of any debts or parts thereof
16		incurred by the authority, including the power to pay
17		premiums on any such insurance; and
18	(4)	Agree to make payments to the state or county
19		government, if the government is authorized to accept
20		payments, as the authority deems consistent with the
21		maintenance of the character of public housing
22		projects or the purposes of this chapter."

SECTION 3. Section 356D-17, Hawaii Revised Statutes, is 1 2 amended to read as follows: "[+] §356D-17[+] Public works contracts. [The] Except as 3 4 provided in section 356D- , the authority may make, execute, 5 and carry out contracts for, or in connection with, any public 6 housing project in the manner provided in chapter 103D and 7 section 103-53; and, with regard to the contracts, the term 8 "procurement officer", as used in chapter 103D, shall mean the 9 authority or officer authorized by the authority to act as its 10 contracting officer. Unless made and executed in the name of 11 the State, each contract made and executed as authorized in this 12 section shall state therein that it is so made and executed." 13 SECTION 4. Statutory material to be repealed is bracketed 14 and stricken. New statutory material is underscored.

SECTION 5. This Act shall take effect on July 1, 2007.

Report Title:

Public Housing Repairs; Partnerships

Description:

Allows the Hawaii Public Housing Authority (HPHA) to work with nonprofit organizations to repair and renovate public housing projects without regard to the Procurement Code. Authorizes HPHA to collaborate with the Department of Public Safety to allow skilled prisoners to perform repairs on public housing projects. (HB1762 HD1)
