RELATING TO NEW MARKETS TAX CREDIT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 235, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated and to read as follows: 3 "\$235- New markets tax credit. (a) Section 45D (with 4 respect to new markets tax credit) of the Internal Revenue Code 5 shall be operative for the purposes of this chapter, except as 6 7 otherwise provided in this section. (b) Each taxpayer subject to the tax imposed by this 8 chapter who holds a qualified equity investment on a credit 9 allowance date of that investment, which occurs during the 10 taxable year, may claim a credit against the taxpayer's net 11 12 income tax liability for the taxable year. The amount of the credit shall be deductible from the taxpayer's net income tax 13 liability, if any, imposed by this chapter for the taxable year 14 in which the credit is properly claimed on a timely basis. 15 (c) The amount of the credit shall be equal to the 16
