

A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	DE II ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII.
1	SECTION 1. The purpose of this Act is to establish a
2	demonstration project in Waianae on Oahu and in South Kohala on
3	the island of Hawaii, to identify the cost drivers that force
4	the price of housing to a level beyond the means of most Hawaii
5	residents and to address those cost drivers.
6	SECTION 2. (a) The Hawaii housing finance and development
7	corporation shall establish and operate an affordable housing
8	demonstration project. The demonstration project shall be
9	located in Waianae on Oahu and South Kohala on the island of
10	Hawaii.
11	(b) The Hawaii housing finance and development corporation
12	shall issue a request for proposals to develop the two
13	affordable housing projects. The request for proposals, at a
14	minimum, shall include the following:
15	(1) No environmental assessment, environmental impact
16	statement, or building permits shall be required;

(2) The developer shall indicate the infrastructure that

shall be built in the development;

1	(3)	The demonstration project shall be exempt from county
2		requirements for the installation of curbs, gutters,
3		and sidewalks;
4	(4)	The developer shall bond the project. Upon the final
5		inspection of the project, the bond shall be used to
6		correct any discrepancies that are found; and
7	(5)	The developer shall provide:
8		(A) An itemized cost of the project;
9		(B) A separate listing of the markup; and
10		(C) A separate listing, if any, of the cost of
11		studies or approvals required for the project.
12	(c)	The proposals from the developers shall contain the
13	following	elements:
14	(1)	The location of appropriate state land in the target
15		areas to be developed as leasehold property for the
16		homebuyers;
17	(2)	Plans and specifications for a minimum of twenty units
18		and maximum of forty units;
19	(3)	Sales price of the units on a leasehold basis;
20	(4)	Parks and other recreational facilities that will be
21		built as part of the development; and

1	(5)	Essentia	l serv	ice facil	ities	that	will	be 1	built	as
2		part of	the dev	velopment	, such	as :	fire	stat	ions.	

- 3 (d) The Hawaii housing finance and development corporation
- 4 shall submit to the legislature a report of its findings and
- 5 recommendations on the demonstration project no later than
- 6 twenty days prior to the convening of the regular session of
- 7 2010.
- 8 SECTION 3. This Act shall take effect on July 1, 2007, and
- 9 shall be repealed on July 1, 2010.
