A BILL FOR AN ACT

RELATING TO THE HAWAII ENERGY POLICY FORUM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The Hawaii energy policy forum comprises a

diverse group of stakeholders representing the renewable energy

industry, electric utilities, labor organizations, oil and

natural gas suppliers, environmental groups, and federal, state

and local government, including representatives from the

 $oldsymbol{6}$ neighbor islands. The vision of the policy forum is to develop

7 smart energy solutions to sustain a healthy, prosperous, and

8 secure Hawaii. Its mission is to be a collaborative forum for

9 sharing ideas and information, seeking consensus, recommending

10 and advocating policies and initiatives, and promoting civic

11 action to achieve a preferred energy future for Hawaii. Since

12 its inception in 2002, the policy forum, in cooperation with the

13 legislature and the administration, has led the efforts to

14 initiate a number of improvements to Hawaii's energy laws and

15 policies. It has held a number of informational briefings that

16 have been free and open to the public in its effort to educate

17 Hawaii's residents about energy issues.

- 1 A unique feature of the policy forum is its Ten Point Plan: 2 an action plan that identifies specific areas of interest on which the forum will focus. It includes specific action items 3 for each point and methods to achieve each goal. As with all 4 the policy forum's outcomes, the Ten Point Plan is determined by 5 6 a consensus of the policy forum's membership. The policy forum 7 updated its ten point plan in August 2007 to take into account 8 the initiatives that have been passed in the years since the 9 forum's inception and the work that remains to be completed. 10 Although much has been accomplished in the past few years 11 to position Hawaii as one of the leaders of renewable energy and 12 energy efficiency in the country, there is much more that must 13 The cost of oil has increased substantially during 14 2007, and this is expected to have a profound negative effect on Hawaii's economic well-being. This requires yet more steps be 15 16 taken to reduce Hawaii's dependence on fossil fuels. Therefore, it is imperative that the policy forum continue its 17 collaborative work with all energy stakeholders to ensure that 18 Hawaii has a sustainable, renewable, and affordable energy 19 20 future. 21 The purpose of this Act is to appropriate funds so that the

1 concepts, and recommendations of the updated ten point plan to 2 meet Hawaii's energy goals. This will allow stakeholders to 3 continue their work from planning to implementation, and it will 4 permit further engagement of policymakers, decision-makers, and 5 consumers on issues relevant to creating Hawaii's preferred 6 energy future. 7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so much 9 thereof as may be necessary for fiscal year 2008-2009 to 10 continue the work of the Hawaii energy policy forum for the 11 purpose of: (1)12 Implementing the detailed action plans to achieve the 13 Hawaii energy policy forum's Ten Point Plan to meet 14 Hawaii's energy goals; 15 (2) Monitoring energy-related policies and programs to 16 continually assess and update tangible goals, 17 objectives, desired outcomes, and actions to achieve 18 the energy vision and goals of the Hawaii energy 19 policy forum; 20 Continuing to refine and evaluate benchmarks for (3) 21 measuring outcomes of energy implementation

strategies;
