### A BILL FOR AN ACT

RELATING TO CHILDREN'S HEALTH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that recent neuroscience 1 research demonstrates that a child's early years are the most 2 crucial in the child's cognitive, emotional, social, and 3 physical development. The legislature affirms that there are 4 tremendous opportunities for preventive work with children and 5 families as well as the predictable, costly consequences of not 6 doing so. The legislature further finds that quality early 7 childhood education and child care that support all aspects of 8 9 early development are crucial to ensuring that every child starts his or her formal education healthy, safe, and ready to 10 11 learn and succeed. A child's ability to function in the classroom is essential. This goal can be achieved by assuring 12 that each child can hear, see, and speak at a minimal level 13 14 prior to starting school.

15 The legislature further finds that early screening, 16 identification, and intervention for developmental delays and 17 psychosocial problems improve children's outcomes and have a 18 critical influence on school success and family functioning. HB HMS 2007-4659

The ideal is to provide each child with ongoing access to 1 quality primary healthcare and, to the greatest extent possible, 2 a safe home and community environment. However, not all 3 children have access to quality primary healthcare prior to the 4 start of school. It is in the state's interest to provide 5 developmental screening and assessment that will detect 6 deficiencies and provide corrections before they hinder a 7 child's ability to function in school. 8

9 The departments of health, education, and human services 10 currently provide families access to various community health 11 services. However, parents are often unaware of or choose not 12 to avail themselves of these services. Meanwhile, their 13 children do not receive proper screening, evaluation, or 14 referrals for correction or treatment.

15 The purpose of this Act is to provide a means for a child 16 to be screened prior to the start of the child's education, at 17 the child's first entry into preschool or elementary school, to 18 provide for diagnosis, referral, correction or treatment, and to 19 integrate the efforts of community and state organizations 20 related to screening under this Hawaii childhood screening 21 initiative.

SECTION 2. Chapter 321, Hawaii Revised Statutes, is 1 amended by adding a new part to be appropriately designated and 2 to read as follows: 3 "PART . EARLY CHILDHOOD SCREENING 4 Early childhood screenings. (a) Prior to the §321-5 start of a child's entry into either preschool or kindergarten, 6 the parents or guardians of a child shall have the child 7 screened for vision, hearing, and development. Screening 8 certification of the child may be provided by: 9 (1) The child's pediatrician; or 10 (2) Any primary healthcare provider. 11 If the child does not have a pediatrician or primary healthcare 12 provider, the department may provide the screening or refer the 13 child to a primary healthcare provider at no cost to the child 14 or family. 15 (b) Beginning with the 2009-2010 school year, a 16 certificate of screening shall be presented to the school where 17 the student enters: 18 (1) Preschool; or 19 (2) Kindergarten or first grade, whichever is the 20 student's entry grade level for elementary school. 21

13	(2) Inform parents and guardians of their responsibilities
14	to ensure that the child's psychological and
15	physiological development are progressing
16	satisfactorily;
17	(3) Provide assistance and advice to parents and guardians
18	in meeting their responsibilities under paragraph (2);
19	(4) Provide additional evaluation or referrals as deemed
20	necessary; and

(5) Use standardized screening tools and referral 1 protocols developed by the Hawaii childhood screening 2 initiative advisory committee. 3 (e) A waiver signed by a child's parents or guardian 4 indicating that they do not want to have the child screened 5 based on their religious beliefs shall be accepted by the school 6 in lieu of the certificate required in subsection (a). 7 (f) As used in this section, "primary healthcare provider" 8 means any healthcare practitioner who provides, or a facility 9 through which is provided, any medical evaluation or treatment 10 including dental and mental health evaluation or treatment. 11 Hawaii childhood screening initiative advisory 12 §321committee; establishment. (a) There is established the Hawaii 13 childhood screening initiative advisory committee that shall be 14 attached to the department of health, for administrative 15 16 purposes, to: (1) Plan and implement a statewide screening initiative 17 for all children from birth to eight years of age; 18 Develop and implement a screening certification 19 (2) program for children entering preschool and elementary 20 school; and 21

SECTION 3. There is appropriated out of the general
revenues of the State of Hawaii the sum of \$500,000 or so much
thereof as may be necessary for fiscal year 2008-2009 for the

screenings.

9 The sum appropriated shall be expended by the department of10 health for the purposes of this Act.

### Report Title:

Early Childhood; Vision and Hearing Testing

#### Description:

Provides a means for childhood screening required for entry into school, from birth to eight years of age, and establishes the Hawaii Childhood Screening Initiative Advisory Committee.
