A BILL FOR AN ACT

MAKING AN APPROPRIATION TO HIRE TEACHERS THROUGH THE TEACH FOR AMERICA PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to appropriate funds
- 2 to raise the number of highly accomplished recent college
- 3 graduates teaching in underserved urban and rural communities in
- 4 Hawaii and to increase the number of schools and communities
- 5 served by the Teach For America Program.
- 6 This Act is intended to build a broader pipeline of
- 7 talented and experienced future leaders in public education and
- 8 education reform in Hawaii.
- 9 SECTION 2. For the purposes of this Act:
- 10 "High needs" means a school in which a substantial
- 11 percentage of students are eligible for free or reduced price
- 12 government sponsored meals.
- "Highly qualified" has the same meaning as that term is
- 14 used in section 9101 of the Elementary and Secondary Education
- 15 Act of 1965 (20 U.S.C. 7801).

4	(1)	Provide ten highly qualified teachers who have pledged

7	(2)	Pay the cost of recruiting, selecting, training, and
8		supporting new teachers hired pursuant to this Act;

10	(3)	Provide ongoing professional development activities
11		for the selected teachers in the classroom, including
12		regular classroom observations and feedback, and
13		ongoing training and support.
14	The o	department of education is authorized as necessary to
15	effectuate	e the purposes of this Act, including selecting the
16	high need:	s schools participating under this Act.
17	(b)	The department of education and the Teach for America
18	Program sl	nall report to the legislature twenty days prior to the
19	convening	of the 2008 legislative session. The report shall
20	include:	
21	(1)	Data on the number and characteristics of the teachers

provided to schools under this Act;

1	(2)	An externally conducted analysis of the satisfaction
2		of the department of education and supervising
3		principals with respect to the teachers hired pursuant
4		to this Act;
5	(3)	Comprehensive data on the background, training,
6		placement sites, professional development, and the
7		retention rate of the teachers hired under this Act;
8		and
9	(4)	A comparison of the academic achievement of students
10		taught by teachers hired pursuant to this Act and
11		other teachers in the same schools and positions.
12	SECT	ION 4. There is appropriated out of the general
13	revenues	of the State of Hawaii the sum of \$100,000 or so much
14	thereof a	s may be necessary for fiscal year 2008-2009 to hire
15	teachers	in the Teach for America Program pursuant to this Act.
16	The	sum appropriated shall be expended by the department of
17	education	for the purposes of this Act.
18	SECT	ION 5. This Act shall take effect on July 1, 2008.
