### A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that consumers are attempting to
2 learn more about their health. Last year, some 113 million

3 people used the Internet to get health information. Each day,

4 eight million people are doing their own research on diets,

5 medical conditions, diseases, treatment options, and in some

6 cases, the performance of hospitals and doctors.

7 The legislature also finds that in an era of more

 $oldsymbol{8}$  sophisticated means and information-savvy consumers, simple

9 questions regarding the price of medical procedures and services

10 are difficult to obtain. In an increasingly consumer-driven

11 medical market, transparency about price for services is crucial

to empowering consumers in making intelligent decisions about

13 their health.

14 The purpose of this Act is to mandate the progressive

15 disclosure of prices of medical services and procedures.
