A BILL FOR AN ACT

RELATING TO NURSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
- 2 amended by adding a new subpart to part VII to be appropriately
- 3 designated and to read as follows:
- 4 " . NURSING TEACHER LOAN FORGIVENESS PROGRAM
- 5 §304A- Definitions. As used in this subpart, unless the
- 6 context otherwise requires:
- 7 "Program" means the nursing teacher loan forgiveness pilot
- 8 program authorized under this subpart.
- 9 "Oualified loan" means a student loan incurred while
- 10 earning a master's degree in nursing or a doctoral degree in
- 11 nursing or related field from a private or public institution of
- 12 higher education located in this state.
- "Qualified position" means full-time employment by a
- 14 private or public institution of higher education located in
- 15 this state to teach classes required to earn a degree or
- 16 certificate in nursing.
- "Student" means any individual domiciled in this state who
- 18 attends or is about to attend a private or public post-secondary



- 1 master's or doctoral degree in nursing and who intends to teach
- in a nursing program in Hawaii designed to prepare students for 2
- 3 licensure as registered nurses.
- 4 §304A-Nursing teacher loan forgiveness program;
- establishment; administration; qualifications. (a) 5 There is
- 6 established a program to be known as the nursing teacher loan
- 7 forgiveness program to be placed within the University of Hawaii
- 8 for administrative purposes. The program shall be funded by the
- 9 nursing teacher loan forgiveness special fund created in part V.
- 10 The University of Hawaii shall develop and maintain a
- 11 nursing teacher loan forgiveness program for implementation
- 12 beginning in the fall semester of the 2009-2010 academic year.
- 13 The program shall provide for payment of up to \$20,000 for all
- 14 or part of the principal of and interest on a qualified loan if
- 15 the person is hired for a qualified position and stays in a
- 16 qualified position for a period of not less than five
- 17 consecutive academic years after the person has earned an
- 18 advanced degree in nursing. Repayment of loans through the
- 19 program may be made using moneys in the nursing teacher loan
- 20 forgiveness special fund.
- 21 (c) A nursing teacher shall meet the following conditions
- 22 to qualify for the program:

- 3 §304A- Annual report. (a) The University of Hawaii
- 4 shall publish a report every year commencing September 1, 2009.
- 5 The report shall include information regarding the operation of
- 6 the program, including:
- 7 (1) The total number of participants in the program;
- 8 (2) The amount of funds applied toward loan repayment or
- 9 forgiveness; and
- 10 (3) The source of those funds.
- 11 (b) The annual report shall be submitted to the governor
- 12 and the legislature no later than twenty days prior to the
- 13 convening of each regular session."
- 14 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 15 amended by adding a new section to subpart C of part V to be
- 16 appropriately designated and to read as follows:
- 17 "§304A- Nursing teacher loan forgiveness special fund.
- 18 There is created in the state treasury the nursing teacher loan
- 19 forgiveness special fund. The fund shall consist of all moneys
- 20 appropriated to the fund by the legislature and any gifts,
- 21 grants, and donations received in conjunction with the
- 22 administration of the nursing teacher loan forgiveness program

- 1 established in part VII. Moneys deposited in the special fund
- 2 shall be expended for the administration of the nursing teacher
- 3 loan forgiveness program."
- 4 SECTION 3. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$1 or so much thereof
- 6 as may be necessary for fiscal year 2008-2009 to be deposited
- 7 into the nursing teacher loan forgiveness special fund.
- 8 SECTION 4. There is appropriated out of the nursing
- 9 teacher loan forgiveness special fund the sum of \$1 or so much
- 10 thereof as may be necessary for fiscal year 2008-2009 for the
- 11 nursing teacher loan forgiveness program established by this
- 12 Act.
- 13 The sum appropriated shall be expended by the University of
- 14 Hawaii for the purposes of this Act.
- 15 SECTION 5. New statutory material is underscored.
- 16 SECTION 6. This Act shall take effect on July 1, 2008.
