A BILL FOR AN ACT

RELATING TO CARE HOMES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 346-53, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows: 2 The director, pursuant to chapter 91, shall determine 3 the rate of payment for domiciliary care, including care 4 provided in licensed developmental disabilities domiciliary 5 homes, community care foster family homes, and certified adult 6 foster homes, to be provided to recipients who are eligible for 7 8 Federal Supplementary Security Income or public assistance, or The director shall provide for level of care payment as 9 10 follows: [For] Beginning on July 1, 2008, for adult residential 11 (1)care homes classified as facility type I, licensed 12 13 developmental disabilities domiciliary homes as defined under section 321-15.9, community care foster 14 family homes as defined under section 346-331, and 15 certified adult foster homes as defined under section 16 321-11.2, the state supplemental payment shall not 17 18 exceed [\$641.90;] \$686.83;
