### A BILL FOR AN ACT

RELATING TO THE VIOLENCE AGAINST WOMEN ACT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the federal Violence
 Against Women Act (VAWA) is targeted toward ensuring that women
 who are victims of domestic violence or sexual assualt,
 including undocumented immigrants, are protected from their
 perpetrators.

6 The United States Department of Justice, through the Office 7 on Violence Against Women, encourages nonprofits, community-8 based organizations, and other social service organizations to 9 aid victims of violence by providing legal and social services 10 to enable women to report abuse and cooperate with law 11 enforcement without fear of being legally reprimanded due to 12 their immigration status. VAWA makes undocumented immigrants 13 who are victims of domestic violence or sexual assault eligible 14 to apply for a work permit and a U-visa, which provides 15 immigration status to noncitizens willing to assist authorities 16 investigate crimes.

1 fear of deportation. Many victims are unfamiliar with the laws 2 that may protect them and their children. Additionally, women 3 who have cooperated with authorities have been unable to 4 financially support their families because of a lack of job 5 experience, job training, and interviewing skills.

6 The purpose of this Act is to establish a pilot project to 7 enable community-based organizations to provide legal advice and 8 social services to victims of domestic violence or sexual 9 assault who are undocumented immigrants, in accordance with the 10 goals of VAWA.

11 SECTION 2. (a) The department of human services shall 12 establish a pilot project to assist undocumented immigrants who 13 are victims of domestic violence or sexual assault, including 14 assistance with helping victims to achieve federal Violence 15 Against Women Act status. The department may contract with a 16 nonprofit organization to operate the pilot project and shall 17 only contract with a nonprofit organization providing services 18 that has expertise relating to the federal Violence Against 19 Women Act.

20 (b) The pilot project shall provide the following services
21 to undocumented immigrants who are victims of domestic violence
