A BILL FOR AN ACT

RELATING TO MENTAL HEALTH COUNSELORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 14, Session Laws of Hawaii 2006 (Act 14),
- 2 was enacted to amend the definition of the "practice of mental
- 3 health counseling" by clarifying that professional counseling
- 4 services are determined by the specialized education, training,
- 5 and experience that a practitioner has completed. In addition,
- 6 Act 14 sets terms and conditions for interns and post-graduate
- 7 work.
- 8 The purpose of this Act is to clarify the requirements for
- 9 mental health counselor licensure by establishing that those
- 10 persons who applied to the department after July 1, 2005, and
- 11 graduated from an accredited program before July 1, 2007, may be
- 12 eligible for licensure.
- 13 SECTION 2. Section 453D-7, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§453D-7 Application for licensure as a mental health
- 16 counselor. (a) Any person who applies to the department after
- 17 July 1, 2005, and who graduated after July 1, 2007, from an

 - (A) Human growth and development, including but not limited to the study of life span development, strategies to facilitate that development and transitions, theories of learning and personality development, and human behavior to include crisis, disabilities, addictive behavior, and environmental factors;

18		disorders, and educational techniques aimed at
19		preventing such disorders with individuals and
20		families;

15		psychiatry; and
16	(4)	Passed the National Counselor Examination for
17		Licensure and Certification.
18	(b)	An individual who:
19	(1)	Holds current, unencumbered certification as a
20		national certified counselor or a national certified
21		rehabilitation counselor prior to [the effective date
22		of this chapter;] July 1, 2005;

1	(2)	Has passed the National Counselor Examination for				
2		Licensure and Certification, National Clinical Mental				
3		Health Counselors Examination of the National Board				
4		for Certified Counselors, or Commission on				
5		Rehabilitation Counselor Certification examination				
6		after January 1, 2000, and before July 1, 2005; and

15		nursing, or marriage and family therapy; and			
16	(4)	Passed the National Counselor Examination for			
17		Licensure and Certification."			
18	SECTION 3. Section 26H-4, Hawaii Revised Statutes, is				
19	9 amended to read as follows:				
20	"§26H-4 Repeal dates for newly enacted professional and				
21	vocational regulatory programs. $[-(a)-]$ Any professional or				
22	vocational regulatory program enacted after January 1, 1994, and

- 2 The auditor shall perform an evaluation of the program, pursuant
- 3 to section 26H-5, prior to its repeal date [-
- 4 (b) Chapter]; provided that chapter 453D (mental health
- 5 counselors) shall not be repealed [on December 31, 2008]."
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.
