A BILL FOR AN ACT

RELATING TO PUBLIC RESTROOMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the public restroom
- 2 facilities throughout the State have been neglected and are
- 3 unsanitary. This has created an unhealthy environment for
- 4 hundreds of visitors and residents of the State who enjoy the
- 5 beautiful weather and all of the outdoor parks and activities
- 6 that Hawaii has to offer.
- 7 The purpose of this Act is to appropriate funds to ensure
- 8 that all public restroom facilities are consistently well
- 9 maintained and sanitary.
- 10 SECTION 2. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2008-2009 for
- 13 public restrooms in state facilities to be consistently well
- 14 maintained.
- 15 The sum appropriated shall be expended by the department of
- 16 accounting and general services for the purposes of this Act.

SECTION 3. There is appropriated out of the general

- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2008-2009 for
- 4 public restrooms in state parks to be consistently well
- 5 maintained.
- 6 The sum appropriated shall be expended by the department of
- 7 land and natural resources for the purposes of this Act.
- 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2008-2009 for
- 11 public restrooms in city and county parks to be consistently
- 12 well maintained; provided that no funds shall be made available
- 13 under this section unless the city and county of Honolulu
- 14 provides matching funds for the purpose for which this sum is
- 15 appropriated.
- 16 The sum appropriated shall be expended by the city and
- 17 county of Honolulu for the purposes of this Act.
- 18 SECTION 5. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$ or so
- 20 much thereof as may be necessary for fiscal year 2008-2009 for
- 21 public restrooms in county parks to be consistently well
- 22 maintained; provided that no funds shall be made available under

 - 7 much thereof as may be necessary for fiscal year 2008-2009 for
 - 8 public restrooms in county parks to be consistently well
 - 9 maintained; provided that no funds shall be made available under
- 10 this section unless the county of Kauai provides matching funds
- 11 for the purpose for which this sum is appropriated.
- 12 The sum appropriated shall be expended by the county of
- Kauai for the purposes of this Act. 13
- 14 SECTION 7. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$
- 16 much thereof as may be necessary for fiscal year 2008-2009 for
- public restrooms in county parks to be consistently well 17
- maintained; provided that no funds shall be made available under 18
- 19 this section unless the county of Maui provides matching funds
- 20 for the purpose for which this sum is appropriated.
- 21 The sum appropriated shall be expended by the county of
- Maui for the purposes of this Act. 22
