A BILL FOR AN ACT

RELATING TO CAREGIVING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 204, Session Laws of Hawaii 2007 (Act 204), 2 expanded the mandate of the joint legislative committee on 3 family caregiving (JLCFC) by including grandparents of children 4 age 18 years and younger, or 19 years of age or older with physical or cognitive limitations, in the Act's definition of 5 6 family caregiver. The revised definition is now more consistent 7 with the scope of the National Family Caregiver Support Program. 8 Act 204 also required JLCFC to examine the issues facing the 9 population of grandparents raising grandchildren. 10 Numerous government agencies testified before JLCFC 11 regarding how the agencies identify and address the needs of 12 grandparents raising grandchildren. In addition, the executive 13 office on aging presented the 2007 Needs Assessment of
- 14 Grandparents Raising Grandchildren in the State of Hawaii,
- 15 prepared by the University of Hawaii, department of family and
- 16 consumer science.

         The needs assessment indicates that over 14,000
2
    grandparents are primary caregivers for over 33,000
    grandchildren in Hawaii and that these numbers are expected to
3

    grow. While there is a wide range of service needs, the most
    often-cited relate to children's programs, financial assistance,
5
6
    respite, and grandparents' rights. Many of these services are
7
    available, but barriers prevent grandparents from using them.
8
    These barriers include a lack of information regarding the
9
    availability of services, a lack of services in a particular
10
    county, or legal or financial impediments. For instance, in
    focus groups, some grandparents expressed a fear of losing their
11
12
    grandchildren. Others identified a need for an advocate or case
13
    worker to help guide them to the services and through the
14
    various systems.
15
         The legislature finds that the needs assessment provides
16
    critical demographic information and feedback regarding the
17
    programs and services grandparents require to care for their
18
    grandchildren. The findings indicate that the population of
19
    grandparents raising grandchildren faces particular challenges,
20
    different in some ways from the general caregiver population,
21
    and should have a focused task force to specifically address
```

1 those concerns. The legislature further finds that the next 2 step is a comprehensive, coordinated effort to identify: 3 (1)The services that exist to meet the identified needs; 4 (2)Any service deficiencies; 5 (3)Barriers that prevent grandparents from accessing 6 services; and 7 What can be done to facilitate the provision of (4)8 services to grandparents raising grandchildren. 9 The purpose of this Act is to establish a task force to 10 specifically focus on the needs of and issues facing 11 grandparents raising grandchildren. SECTION 2. (a) There is established the grandparents 12 raising grandchildren task force to focus on the needs of and 13 14 issues facing grandparents raising grandchildren. The task force shall consist of a representative of: 15 16 The University of Hawaii, center on aging, to serve as (1)17 co-chair; 18 (2)The University of Hawaii, college of tropical 19 agriculture and human resources, to serve as co-chair; 20 (3)The department of education; 21 (4)The department of human services;

5	(c)	The task force on grandparents raising grandchildren				
6	shall submit an interim report to the legislature and the joint					
7	legislative committee on family caregiving no later than twenty					
8	days prior to the convening of the regular session of 2009 and a					
9	final report to the legislature and the joint legislative					
10	committee on family caregiving no later than twenty days prior					
11	to June 3	0, 2009. The final report shall include, to the				
12	greatest	extent possible:				
13	(1)	A list of the services that exist in each county to				
14		meet grandparents' identified needs;				
15	(2)	A discussion of service deficiencies in each county;				
16	(3)	A discussion of identifiable barriers that prevent				
17		grandparents from accessing services;				
18	(4)	A synopsis of the task force's work and any findings				
19		regarding the task force's responsibilities as				
20		detailed in section 2(b) of this Act; and				
21	(5)	Recommendations, including possible legislation.				

- 1 (d) The task force shall cease to exist on June 30, 2009.
- 2 SECTION 3. This Act shall take effect upon its approval.
