### A BILL FOR AN ACT

RELATING TO THE RE-EMPLOYMENT OF RETIREES BY THE STATE OR COUNTIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature recognizes the changing
- 2 demographics of the workforce; that in fact, the workforce is
- 3 aging with an increasing number of state and county employees
- 4 becoming eligible to retire with full retirement benefits. The
- 5 legislature also recognizes that life spans have increased, not
- 6 only because of advances in medicine and technology, but because
- 7 people are choosing to live healthier lifestyles.
- 8 Ken Dychtwald, noted gerontologist, notes that older adults
- 9 are blessed with longer, healthier lives, and are looking for a
- 10 more fulfilling life (not the typical retirement) and wanting to
- 11 stay longer or enter back into the workforce. Dychtwald offers
- 12 that we are in an era where people will grow old slower, live
- 13 longer, and may never retire, or may retire three or more times
- 14 as they start new careers, go back to school, or even raise a
- 15 second or third family.
- 16 Myths associated with older workers have been found to be
- just myths. Older workers do not get into more on-the-job

- 1 accidents than other workers, they do not have higher rates of
- 2 absenteeism, and their job performance does not decrease with
- 3 age.
- 4 The legislature understands that with the low unemployment
- 5 the State is now experiencing, state and county governments have
- 6 more vacancies occurring with a dwindling number of qualified
- 7 applicants. These government entities, especially the state,
- 8 have many jobs categorized as hard-to-fill, or as being in a
- 9 labor-shortage category.
- 10 While retired state and county employees are now permitted
- 11 to work for temporary periods of eighty-nine consecutive days or
- 12 for less than twenty hours per week without jeopardizing their
- 13 retirement benefits, there is no reason not to afford the state
- 14 and county governments the ability to hire retired state and
- 15 county government employees on a full-time basis, considering
- 16 too that if they do not work for government, they will instead
- 17 work for the private sector. This Act will allow the state and
- 18 county employers to recruit from the same group of qualified
- 19 applicants as do private employers and give the government
- 20 employers equal footing with the private sector employer in
- 21 employing state and county retirees.

1	The legislature believes this Act will strike a balance		
2	between the state and county governments' need to hire skilled		
3	and qualified employees and retired state and county government		
4	employees' desire to continue to work for state or county		
5	government. This Act will allow retired state and county		
6	government employees to again work for the state or county		
7	governments without incurring any negative retirement		
8	consequences, such as the forfeiture of retirement benefits		
9	already earned and being collected by employees.		
10	SECTION 2. Chapter 88, Hawaii Revised Statutes, is amended		
11	by adding a new section to be appropriately designated and to		
12	read as follows:

- 1 retirement benefits for a future retirement date as may be
- 2 allowed by this chapter.
- 3 (d) For the purposes of this section:
- 4 "Jurisdiction" means the city and county of Honolulu; the
- 5 counties of Hawaii, Maui, and Kauai; the department of
- 6 education; the judiciary; the Hawaii health systems corporation;
- 7 the office of Hawaiian affairs; the state executive branch; and
- 8 the legislative branches of the state and county governments.
- 9 "State executive branch" means all the departments of the
- 10 executive branch of the state government, except the University
- 11 of Hawaii, the Hawaii health systems corporation, and the
- 12 department of education."
- 13 SECTION 3. Each jurisdiction, using the provisions of
- 14 section 2 of this Act, shall report annually to the legislature
- 15 no later than twenty days prior to the convening of each regular
- 16 session of the legislature on the number of positions filled
- 17 pursuant to this Act. The report shall include but not be
- 18 limited to job title, salary, and the length of time each
- 19 retirant was hired and other pertinent information.
- 20 SECTION 4. New statutory material is underscored.

SECTION 5. This Act shall take effect on July 1, 2008. 1
