BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

5	employees. An insurer that provides health care coverage to the

7	same coverage to part-time employees of that group or

9	required by this section to pay any part of the premium for that
10	coverage.

12	"Group or association" shall not include any state or
13	political subdivision of any state, or instrumentality thereof.
14	"Health care" includes hospitalization, surgery, medical or
